8 (a) A person commits the crime of assault in the first degree if

9 (1) that person recklessly causes serious physical injury to another by
10 means of a dangerous instrument;

11 (2) with intent to cause serious physical injury to another, the person
12 causes serious physical injury to any person;

13 (3) the person knowingly engages in conduct that results in serious
14 physical injury to another under circumstances manifesting extreme indifference to the
15 value of human life; or

16 (4) that person recklessly causes serious physical injury to another by
17 repeated assaults using a dangerous instrument, even if each assault individually does
18 not cause serious physical injury;

19 **(5) while being 18 years of age or older, that person**

20 **(A) intentionally causes serious bodily injury to a child**
21 **under 12 years of age or to a child under 16 years of age who is mentally**
22 **or physically impaired; or**

23 **(B) recklessly causes serious bodily injury on one or more**

1 **than one occasion to a child under 12 years of age or to a child under 16**
2 **years of age who is mentally or physically impaired.**

3 * **Sec. 2.** AS 11.81.900(b) is amended by adding a new paragraph to read:

4 (65) "serious bodily injury to a child" includes second or third degree
5 burns, a fracture of any bone, a concussion, strangulation, injuries to the skin that
6 involve severe bruising or the likelihood of permanent or protracted disfigurement,
7 including those sustained by striking children with objects, or other physical injury
8 that results in significant physical injury to the child."
