**BILL NO. SB 143**

### **Analysis**

SB 143 places into statute the requirement of a dedicated Investigator hired by the department to support the Board of Architects, Engineers and Land Surveyors (AELES) in their investigative activities.

Personal Services consists of one full-time Investigator III position, Range 18 to conduct investigations into alleged violations and to be directly responsible and accountable to the board.

Estimated travel for investigative work is consistent with the duties outlined in the legislation.

Services include support services for the new position.

Commodities include one-time start up costs and ongoing supplies.
