**A BILL**

**FOR AN ACT ENTITLED**

1 **"An Act relating to brewery licenses and brewery special events permits."**

2 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

3 \* **Section 1.** AS 04.11.080 is amended by adding a new paragraph to read:

4 (22) brewery special events permit.

5 \* **Sec. 2.** AS 04.11.130(e) is amended to read:

6 (e) **Except as provided in (f) of this section and unless** [UNLESS]  
7 prohibited by AS 04.16.030, a holder of a brewery license may sell not more than 36  
8 ounces a day of the brewery's product to a person for consumption on the premises if

9 [(1) THE BREWERY DOES NOT ALLOW LIVE  
10 ENTERTAINMENT, TELEVISIONS, POOL TABLES, DART GAMES,  
11 DANCING, ELECTRONIC OR OTHER GAMES, GAME TABLES, OR OTHER  
12 RECREATIONAL OR GAMING OPPORTUNITIES ON THE PREMISES WHERE  
13 THE CONSUMPTION OCCURS;

14 (2) THE BREWERY DOES NOT PROVIDE SEATS AT THE  
15 COUNTER OR BAR WHERE THE PRODUCT IS SERVED; AND

1 (3)] the room where the consumption occurs is not open before 9:00  
2 a.m. and serving of the product ends not later than 10:00 [8:00] p.m.

3 \* **Sec. 3.** AS 04.11.130 is amended by adding a new subsection to read:

4 (f) A brewery licensed under this section is eligible for a brewery special  
5 events permit that authorizes the holder to sell or dispense beer manufactured on the  
6 brewery premises for consumption on the premises for a specific occasion and for a  
7 limited period of time. The board may issue a brewery special events permit if an  
8 application for the permit is received in the main office of the board at least 10 days  
9 before the date of the event for which the permit is requested. The application must be  
10 signed by the holder of the brewery license or the holder's authorized agent, must  
11 include the written approval of the law enforcement agency having jurisdiction over  
12 the brewery premises, and must be submitted with a fee of \$50. The board may not  
13 issue to a holder of a brewery license more than five brewery special events permits in  
14 a calendar year. A brewery special events permit issued under this subsection must be  
15 surrendered to the board, its agent, or the law enforcement agency approving the  
16 permit within 48 hours after the expiration of the permit. Failure to surrender a permit  
17 may, at the discretion of the board, serve as cause for denial of an application for a  
18 brewery special events permit made in the future by the holder of the brewery license.

19 \* **Sec. 4.** AS 04.21.065(a) is amended to read:

20 (a) A holder of one of the following types of licenses or permits shall post on  
21 the licensed or designated premises three separate warning signs as described in (b) of  
22 this section:

- 23 (1) beverage dispensary license;  
24 (2) restaurant or eating place license;  
25 (3) club license;  
26 (4) brewery license or brewery special events permit; this paragraph  
27 applies only to a brewery that permits a person to sample portions of the brewery's  
28 product;  
29 (5) package store license;  
30 (6) common carrier dispensary license;  
31 (7) recreational site license;

- 1 (8) pub license;
- 2 (9) winery license; this paragraph applies only to a winery that permits
- 3 a person to sample portions of the winery's product;
- 4 (10) caterer's permit;
- 5 (11) special events permit;
- 6 (12) conditional contractor's permit;
- 7 (13) another license or permit issued by the board authorizing
- 8 consumption of alcoholic beverages.
