A BILL

FOR AN ACT ENTITLED

1 **"An Act relating to professional licensing; relating to temporary licenses for some**
2 **professions; and providing for an effective date."**

3 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4 * **Section 1.** AS 08.01.062 is repealed and reenacted to read:

5 **Sec. 08.01.062. Temporary license.** (a) The department shall issue an
6 applicant a temporary license under this section to engage in a profession regulated
7 under this chapter if

8 (1) the applicant

9 (A) is licensed or credentialed to practice the profession in
10 another state or territory of the United States or province or territory of Canada
11 that

12 (i) has requirements for a license to practice the
13 profession that are substantially equivalent to or greater than the
14 requirements listed in the applicable chapter of this title; or

1 (ii) authorizes a scope of practice substantially
2 equivalent to the scope of practice of the corresponding license in this
3 state; or

4 (B) if applicable, meets the qualifications and requirements for
5 a license under the applicable chapter of this title through military education,
6 training, and service under AS 08.01.064(a) and does not already hold a license
7 to practice that profession in another jurisdiction as a member of the armed
8 forces listed in AS 08.01.064(a)(2);

9 (2) at the time of the application, the applicant is not subject to
10 disciplinary action related to the profession in another jurisdiction or the subject of an
11 ongoing review or disciplinary proceeding by the profession's licensing entity in that
12 jurisdiction;

13 (3) within 10 years before submitting an application, the applicant has
14 not committed an act in another jurisdiction that would have constituted grounds for
15 the denial or revocation of a license, certificate, or permit to practice that occupation
16 under this title; and

17 (4) the applicable fees are paid.

18 (b) If the department or applicable board requires that an applicant for a
19 professional license undergo a criminal history record check, the applicant for a
20 temporary license will be subject to the same requirements. The department may
21 consider an application and grant a temporary license before obtaining any resulting
22 report. If the department subsequently receives criminal record information that would
23 authorize the department or board to take disciplinary action, the department or board
24 shall exercise that authority.

25 (c) A temporary license issued under this section is valid for up to 180 days, as
26 determined by the department. An applicant may apply for one 180-day extension,
27 which will be approved at the department's discretion.

28 (d) Notwithstanding any other provision of law, a temporary license issued
29 under this section for an occupation listed in AS 08.01.010, excluding the professions
30 regulated under AS 08.48, AS 08.54, and AS 08.62, satisfies the requirements to
31 temporarily practice the profession for which a license was granted.

1 (e) The department may revoke a license issued under this section if the
2 department finds that the license was secured through deceit, fraud, or intentional
3 misrepresentation.

4 (f) The department shall set fees for temporary licenses under AS 08.01.065.

23 ARMED FORCES OF THE UNITED STATES] who **relocates to** [IS ON ACTIVE
24 DUTY AND ASSIGNED TO A DUTY STATION IN] this state under official
25 [ACTIVE DUTY] military orders;

26 (2) holds a current license or certificate in another **jurisdiction that**
27 **the military servicemember or spouse of the military servicemember has actively**
28 **used during the two years immediately preceding relocation to the** state [,
29 DISTRICT, OR TERRITORY OF THE UNITED STATES, OR THAT IS
30 RECOGNIZED BY THE UNITED STATES, INCLUDING A BRANCH OF THE
31 ARMED FORCES OF THE UNITED STATES, WITH REQUIREMENTS THAT

1 THE DEPARTMENT OR APPROPRIATE BOARD DETERMINES ARE
2 SUBSTANTIALLY EQUIVALENT TO THOSE ESTABLISHED UNDER THIS
3 TITLE FOR THAT OCCUPATION];

4 (3) if required by the department or appropriate board for obtaining a
5 license **or certificate** in the applicant's profession, has been fingerprinted and has
6 provided the fees required by the Department of Public Safety under AS 12.62.160 for
7 criminal justice information and a national criminal history record check; the
8 fingerprints and fees shall be forwarded to the Department of Public Safety to obtain a
9 report of criminal justice information under AS 12.62 and a national criminal history
10 record check under AS 12.62.400;

11 (4) **remains in good standing with**

12 **(A) the licensing authority of the jurisdiction that issued the**
13 **applicant's existing license or certificate; and**

14 **(B) the licensing authority of any other jurisdiction that has**
15 **issued the applicant a license or certificate with a similar scope of practice**
16 **in the profession applied for** [HAS NOT COMMITTED AN ACT IN ANY
17 JURISDICTION THAT WOULD HAVE CONSTITUTED GROUNDS FOR
18 THE REFUSAL, SUSPENSION, OR REVOCATION OF A LICENSE OR
19 CERTIFICATE TO PRACTICE THAT OCCUPATION UNDER THIS
20 TITLE AT THE TIME THE ACT WAS COMMITTED];

21 (5) **submits to the authority of the department or board for the**
22 **purposes of standards of practice, discipline, and fulfillment of any continuing**
23 **education requirements** [HAS NOT BEEN DISCIPLINED BY A LICENSING OR
24 CREDENTIALING ENTITY IN ANOTHER JURISDICTION AND IS NOT THE
25 SUBJECT OF AN UNRESOLVED COMPLAINT, REVIEW PROCEDURE, OR
26 DISCIPLINARY PROCEEDING CONDUCTED BY A LICENSING OR
27 CREDENTIALING ENTITY IN ANOTHER JURISDICTION]; and

28 (6) pays any fees required under this title.
