(This is text I had prepared to deliver telephonically at the Fairbanks LIO, but due to a shortage of meeting time today have been asked to send via email.)

Dear Members of the Senate Transportation Committee,

My name is Cam Webb, and I live in North Pole, off Badger Road.

I work in Fairbanks and sometimes I commute to work by bike. Usually I'll ride to the bus stop and put my bike on the Green Line bus, but when I miss the bus, or when it's a really nice day, I'll ride all the way, and so I've had to sometimes cycle on the shoulder of the Richardson highway. While it's dangerous enough just peddling along, with cars and trucks whizzing past at 65 miles an hour, it is crossing the on- and offramps that is really stressful.

Last year on the morning of October thirteenth I was driving to work, not cycling. At the top of the Badger Road onramp onto the Richardson there were several police cars, stopped, with lights flashing. As I drove past, I caught a glimpse of a crumpled bicycle. It had panniers on it, and I thought I recognized it as the bike of someone I had sometimes seen cycling along the Richardson in the afternoon, heading in the other direction, to North Pole. I didn't know it at the time but that was indeed Matt Glover's bike.

I was deeply moved and angered by the accident. Soon after, I contacted FAST Planning in Fairbanks to ask about getting a safe bike path along the Richardson, which I had heard had already been proposed. I was relieved then to find out that the project was actually going ahead, starting in 2023. Since then I have learned more about Matt Glover and how he was perhaps the most storied bicycle commuter in Interior Alaska.

I think therefore it is highly appropriate to name this new bike path after Matt, as a tribute to him as a person, and to his commitment to non-motorized transport.

I ask you to please pass this Bill on to the Senate.
