Members of the Finance Committee,

My name is Tracy E. Sylvester, I am a commercial salmon/halibut/black cod fisherman currently living and raising my two young children in Sitka, Alaska. Thank you Co-Chair Stedman, Co-Chair von Imhof, and members of the Committee for the opportunity to comment on this issue.

The budget proposes a big cut to an already under-funded education system. My daughter has just started kindergarten, she LOVES Baranof Elementary here in Sitka, AK. She loves her teacher (who would be at risk of losing her job as a new hire) and she loves learning at school. **It breaks my heart that the State of Alaska does not value her education as much as she does.** The threat of cuts has already negatively impacted the entire community: students, teachers, and parents worried that we will have to leave our home to find adequate educational opportunities and job security. **Please make no cuts to education and keep the lives of children out of politics.**

Similarly, UAS has provided educational opportunities to rural Alaskans for decades. The jobs at UAS support the community, and allow Alaskans to stay in Alaska to further their education. **Alaska is a unique place to learn and grow, please do not cut their budget and push higher education out of reach for so many residents.**

The ferries are an absolute necessity to Sitka. When I had to move to Juneau to give birth to my daughter, we were able to move and drive our car on the ferry. Sitka is so small that residents often need to go to another town for one reason or another. The ferry is an affordable way to do that, especially for families. Tourists from the ferries bring money to Southeast, and residents rely on them. **Please no cuts to our ferries.**

Medicaid cuts in Alaska are perhaps the most upsetting of all the concerning proposals in the budget. As someone who has had to rely on Medicaid in the past, I have seen first hand that our system cannot afford any cuts. Medicaid needs more funding for personnel (it is nearly impossible to reach an agent unless you are having a major emergency). Coverage is weak compared to other states, and generally women and children are more heavily impacted by this than men. Yearly Pap smears are not covered, even when requested by the doctor for medical reasons. Births are more dangerous here than in most of the developed world. In 2013, I nearly died at Bartlett Hospital in Juneau because the birthing team was under-staffed and made a series of avoidable errors, the worst being a surgical error that caused me to lose 3 liters of blood internally. It took over 5 hours for the nurse (who was working a short handed shift) to realize there was internal bleeding, then over an hour for the ultrasound tech to get called in to the hospital. I nearly lost my life because the hospital did not have proper staff to handle a common post operation issue.

**When Medicaid makes cuts and stops fully reimbursing hospitals for the work that they are doing, the entire healthcare system suffers. In a state where legislators have been working to restrict the poor's access to abortions, it is very troubling to consider the serious lack of access to quality care and safe hospital births. No cuts to Medicaid.**

I am willing to take a smaller PFD. I am willing to pay a state income tax. I would like to see the state start taxing the oil industry again and would like to hear legislators talking more about how the state got into this financial mess by cutting taxes for oil companies. I would like to continue to raise my children here and support myself as a commercial fisherman. Our people are our most valuable resource, and it is time the State of Alaska starts putting its citizens first.

I am writing this letter in support of Head Start because I have seen how important this program is for our children and families.


Let me first say how Head Start helped me as a person. When I first started working for Head Start in August of 1989, I had no Early Childhood experience, but was a mother of 2. Head Start provided me opportunities to take classes to achieve my CDA, and AAS degree in Early Childhood Education. I am now working toward my BA. I have learned a lot about children through Head Start.

When my last child went through the program, he had some learning disabilities. Head Start had helped me as a parent advocate for the services he needed, and also helped me as a parent on how I can work with him. When he exited the program, his annual IEP meeting with the public school told me that he would not need the service from the Disabilities Program anymore. To this day he is at the top of his class.

I also had a comment from the Kindergarten teacher working at the public school say that she can see when a child has gone through the Head Start Program, and a child who has not. They are kindergarten ready, meaning they have skills they learned through Head Start. Their social and emotional skills are present, and they know basic academic skills for success in kindergarten.

Without Head Start in our communities where are they going to learn the skills they need to succeed in the public school system?

Dear Members of the Committee,

I strongly oppose the Governor's proposed state budget. It is hard to assess what are the worst parts of the proposed budget as there is so much that is so bad. The cuts to education, medicaid and the ferry system are particularly egregious. The benefits we all enjoy through good education of our youth are foundational. Across the State educational opportunity will be greatly reduced under the Governor's proposed budget. If Alaska will not invest in education, then Alaska is jeopardizing its future.

The ferry system is the most affordable means of transportation for students traveling between towns; the ferries also provide rural Alaskans with access to health care, more affordable shopping, and recreation. The ferry systems connects families and communities across the many miles of SE Alaska. Eliminating the ferries is punitive to coastal Alaskans.

I support a reasonable limit on Alaska's permanent fund dividend of \$1000. I oppose all retrospective PFD issuance. I also support a modest income tax. Right now, far too many people are earning their livelihood in Alaska then leaving the State to spend what they have made elsewhere. Alaska provides services to these people during their time in state; those who earn a living here should contribute to maintaining those services. An income tax makes sense. I also support increases to oil taxes, maybe looking to tax policy similar to Norway.

I am also strongly opposed to redirecting raw fish tax from coastal communities to state coffers. Coastal communities provide essential services to their fishing fleets, and local fishermen depend on those services. Raw fish tax not only supports local fishermen but by funding harbor department personnel and staff, raw fish tax also provides community benefits to commercial, charter, sport and subsistence fishermen.

In sum, I ask you to reject the Governor's budget and to instead develop a budget that prioritizes education, supports coastal residents, and invests in Alaska's future.

## April 12, 2019 Testimony for Senate Finance

Thanks to all the Alaska State Legislators for their hard work in trying to create a workable budget for the state this year.

My name is Rosemary Carlton. I have lived in Alaska for 50 years. Through those 50 years, I have never been as stunned with a proposed state budget as I have this year. In 1969, before the “oil boom” the people of Alaska helped support the State budget by paying a small income tax and an even smaller school tax and we did not receive a PFD. I strongly support both these means of raising revenue while maintaining a moderate PFD for the state if it means small class sizes in our schools, fairly paid teachers, a reliable ferry system, strong healthcare assistance for those who need it, reasonable Pioneer Home fees and the termination of **excessive tax breaks for oil companies**. Of upmost importance to me is the continued **protection and full operation** of the Sheldon Jackson Museum with improvements to the Stratton Library allowing parts of the building to be leased providing revenue. I just heard this morning that SJM is not funded after July 1. I hope this is in error.

The Sheldon Jackson Museum is part of a National Historic Landmark District and is on the National Register for Historic Places. It has been suggested this part of Alaska’s heritage be “investigated” for the potential of sale of it to the highest bidder. How divesting itself of an iconic part of Alaska’s history that in the overall picture of State spending is like the proverbial, “drop in a very large bucket,” is beyond my comprehension. The museum contains objects that represent all of Alaska’s Native cultures. It has a professional staff that cares for the artifacts. The Museum is one of the States top tourist attractions with over 14,000 people coming through last year bringing in \$42,175 in revenue which is enough to help maintain the building.

Museums are not created to be money makers, that is not their purpose, they are created to preserve and protect in the public trust. The state of Alaska holds the collection of the Sheldon Jackson Museum in the public trust in perpetuity. These strong words are backed with laws and ethics to back them up. I wonder what the State's reaction would be if the investigation to sell the museum actually recommended its sale and then it found itself embroiled in never ending litigation. If the Governor thinks he would be saving money by selling our history, he needs to be reminded of the high cost of lawyers and the pace at which litigations move. The contract signed between Sheldon Jackson College and the State of Alaska clearly states "The State will maintain the integrity of real and personal property conveyed to the State under this agreement as a single collection...."

Please, before taking these drastic actions of even considering the sale of Sheldon Jackson Museum or taking crippling amounts of money from any essential State services, bring back money to the state that is now being giving to oil companies, reinstate an income tax, a school tax and yes, share some of the "oil wealth" with the people of the state with a moderate PFD, but don't make us the first state to sell its history and culture.

**The Silver Hand Program**, a program that authenticates native made art and adds value to an artist's marketing campaign.


