## FISCAL NOTE ANALYSIS

### Analysis

Without a clearly defined nomination process, an accurate prediction of new work volume is difficult to calculate.

At a minimum, the Department estimates the value of time for spending one hour per week on list maintenance would be \$2.5. This number assumes no vetting of the nominations to confirm service. Such vetting would double the time expenditure per week, resulting in an expense of \$5.0 annually. Finally, the Department would also have to add any cost for processing transactions associated with the Department accepting gifts, donations, and grants, and the Department cannot predict the number or size of these transactions.

However, it seems reasonable to expect the yet-to-be-established mechanism of accepting and applying such revenues to the various expenses incurred will be structured so as to create no net cost, so the Department reasonably assumes these revenues will offset expenses and offers this zero Fiscal Note.
