I am writing you to request that you support HB275 which supports the Extension of the Alaska Board of Massage Therapists. I support the work of the Board and ask for your support in moving this bill through committee.

I live in Juneau and have practiced Massage Therapy for 23 years. I work in a chiropractic office and am sole proprietor of TLC Massage Therapy, a private studio.

Due to continuing education requirements that did not exist prior to AS 08.61, therapists have increased knowledge and are better able to serve their clients and patients. Medical massage is more available due to a better understanding of how to approach dysfunction in soft tissue. Education requirements have created opportunities for therapists that may no longer practice massage but desire to continue to work in the field and have become instructors or billing specialists. A better understanding of how massage can enhance wellness and have a positive effect on daily living has become available to clients, patients and medical professionals. A door has opened to conversations that did not readily exist prior to the law coming into effect.

Due to the Board's statutory requirements Standards of Practice have been adopted as well as regulations that did not exist prior to the statute thus creating a better understanding by the therapist of what is expected which in turn creates a safer setting for the consumer to receive massage.

I would appreciate your support moving this bill through.

## **Information about the Board of Massage Therapists and HB 275**

David Edwards-Smith, Chair

January 19, 2018

### **What is a Massage Therapist?**

Because of state licensing, a massage therapist is recognized as a legitimate healthcare professional. These health care professionals use hands-on manual techniques to effect a client's soft tissues to enhance function or promote well-being. The field of massage therapy is comprised of hundreds of techniques including expertise in spa related relaxation and expertise in orthopedic and medical related massage.

### **Why do we need the Board of Massage Therapists?**

The board is comprised of five members, four of which are licensed and highly trained massage therapy professionals. This team of professionals have an invaluable combination of experience and knowledge to make informed decisions that serve the public interest. These members, which have been carefully selected by the governor and ratified by the Alaska State Legislature, have the unique ability to navigate the complexities of this diverse group of licensees. The Board of Massage Therapists uses its experience to make informed decisions as it reviews new applicants, education curriculum, continued education of renewing applications, case investigations, regulation projects, and statutory recommendations. Only a board of experienced members of the public with careers as massage professionals can effectively navigate the nuances of the program and respond timely to practice changes.

The Board of Massage Therapists is expected to understand the standards of practice and code of ethics in the context of the techniques performed by massage therapists in a variety of settings. Massage therapists are employed in spa settings, chiropractic clinics, physical therapy clinics and fitness centers. The education required to practice massage therapy is a gateway to opportunities for a career in a variety of situations. With a standard of practice code of ethics now in place, the public can be assured that there is a process for complaints to be addressed if there is a suspected violation. In partnership with the Division of Corporations, Business and Professional Licensing, the board uses their collective experience to ensure public safety.

### **Board Accomplishments Since Its Inception in 2015**

2015

- The board began training and meeting.
- The board began approving transitional licenses. One of the many tasks the board is responsible for is approving all license applications. During the legislative hearings on whether to license this industry, the Alaska Massage Therapy Association indicated there were approximately 600 massage therapists practicing in Alaska. That estimate was below

50% of the actual number; so far, more than 1,400 applications have been processed resulting in over 1,100 licenses being issued. Applications for licensure go through an investigations process to determine if they are falsified or the applicant's criminal background is in question. More than 50 applications have been forwarded to the division for investigation. Ten applicants have been denied licensure due to prostitution or other crimes of moral turpitude, and one license has been revoked for inappropriate touching of clients.

- **The board has reached out to boards in other states to learn best practices.** Being a new board, with a new licensing law, we recognized a need to draw on the experience of others. Alaska has been a member of the Federation of State Massage Therapy Boards since September 2015. Each year one person attends the conference. So far two board members and the program's only dedicated staff member have networked with other state boards around the nation to learn to create better regulations and get an improved understanding of what issues other states are facing. The goal is to better inform our licensees and better serve our population.

## 2016

- **The board has worked with similar industries to share knowledge and to mature the program.** In January, the board was lobbied by Rolfers to state their stance on the Rolfing exemption and to seek support in pursuit of their own licensing. The board has sent written support and verbally encouraged their path to obtaining their own licensing.
- **In December, the board drafted statute changes and sought sponsorship to increase required massage training hours for new applicants.** HB110 was introduced in Alaska State Legislature in January 2017. After public testimony by massage therapists, the board reduced the proposed increase from 750 to 625 hours, which is consistent with national recommendations.
- **Two members of the board were reappointed and confirmed.**
- **As required by statute, the board created, amended, and adopted regulations to implement Standards of Practice and a Code of Ethics.**
- **Members of the board have met with the FBI and Department of Labor and Workforce Development regarding human trafficking in Alaska.** Human trafficking in the massage industry is a nationwide issue which impacts all massage therapists. Obtaining licensure was an important step for Alaskan massage therapists in changing public perceptions toward our profession. Since 2016, members of the board have been networking with The Innocence Project (<https://www.innocenceproject.org/>) and Polaris (<https://polarisproject.org/>) to reduce human trafficking in our industry.

## 2017

- **In March, HB145 was introduced. This bill would remove fingerprinting requirements and provide exemptions for therapists in rural Alaska where fingerprinting services are not available.** Eliminating all fingerprinting limits the board's

ability to screen out of state applicants for crimes of moral turpitude. The board supports this legislation with minor amendments.

- **The Division of Corporations, Business and Professional Licensing has worked with the Department of Public Safety and licensees to rapidly—but safely—issue licenses.** The online renewal process for 2017 was seamless. As of December of 2017, the Division has processed 1,403 applications for massage therapy licensure.
- **The board's audit by the Division of Legislative Audit concluded that the “board was operating in the public’s interest” and it is recommended that the board’s sunset date be moved to June 30, 2022.**
- **One board member worked with the Apprenticeship Task Force and Alaska Department of Labor and Workforce Development to create a massage apprenticeship program as required by statute.** On November 30, 2017, the board adopted an apprenticeship program model that resulted regulations requiring apprenticeship programs to meet certain national standards.
- **On December 1, 2017, the board adopted guidelines for discipline and barrier crimes as requested by the division and the Department of Law.** There are currently no lawsuits filed nor have there been any since the board was formed in 2015.
- **Since its formation, the board has worked hard to hear and give support to massage therapist’s requests.** The majority of concerns are regarding fees, continuing education hours, and fingerprinting. The board has received hours of public comment and has responded by requesting the division reduce licensing fees twice. The cost of fees has been reduced from \$610.00 in 2015 to \$550.00 in 2017. Seeing a problem with the bloodborne pathogens education requirement and upon receiving complaints from applicants and licensees, the board is seeking to reduce the requirement to two required CEU’s.
- **The board has worked diligently to keep expenses down by decreasing travel costs and increasing the use of teleconferencing/videoconferencing.** The role of a board member is a voluntary position, and board members do not receive per diem for teleconference meetings.

### What To Expect In 2018

- **The board is currently researching massage curriculum in order to help applicants determine if their schools and curriculum are eligible to be considered for licensing.** A subcommittee meeting was held on January 1, 2018, via teleconference, and the topic is expected to be resolved at the board’s next regular meeting in March.
- **The public can expect monthly newsletters that inform subscribers of board activity.**
- **The next face-to-face meeting of the Board of Massage Therapists will be held in Juneau on March 8-9, 2018.** Once the location has been determined, the meeting will be publicly noticed on the state website and in *Anchorage Daily News*.

I am writing to inform you that I fully support the extension of HB 275 for the continuation of the Licensing Board of Massage Therapy. Oversight by a board is not only beneficial for the therapist, but the general public as well. We recognize proper oversight ensures that all health care providers, in addition to the public, can have confidence that massage therapists have been vetted appropriately and are being held to the same high professional standards, including ethics, HIPPA and continuing education as the State of Alaska does all other associated health care providers.

I have been a Massage Therapist in Anchorage for 15 years, and am a Co-owner of a Medical Masssage Therapy clinic in Anchorage. I have been very grateful for, and pleased with, the expectations of the Board in holding Therapists to a high standard of ethics and continuing education to qualify for State Licensure. We now have a State Board which holds us to a unified standard of care which allows qualified applicants to become credentialed and recognized with many major insurance companies. This allows our patients to receive specialized treatment outlined by their referring physician by utilizing their insurance benefits. This makes a huge difference in our patients well-being by eliminating the stress and anxiety associated with their health care costs and provides a reduction in demand within the health care system overall.




# Licenses Status as of 1-21-18

I am a fairly new licensed massage therapist in Alaska. Given the public letters and complaints sent to this committee, I thought I'd add two personal experiences to the commentary.

Having been through the application process for both my initial and renewal license in the last year, I'd like to convey my experience.

The initial cost of licensing was approximately \$660.00 including finger printing fees. While this amount was quite high, I was willing to pay it to enter my new profession. I was pleasantly surprised in 2017 to find that the renewal fee was only \$290.00. This amount is one I find reasonable for a two year license and appreciate the boards work in helping to lower this cost.

My initial application required a lot of paperwork to be turned in and I spent some time waiting on various agencies like my school and testing facility to forward necessary information on to the state. I waited approximately two months to get my license, though once my application was fully complete, I only waited 2 weeks for the department to issue me a license.

My renewal was quick, efficient, done entirely online and issued with no wait. This shows improvement in processing and efficiency for the department, something I also appreciate the board and examiners working towards.

Fees have gone down significantly and efficiency has improved in the last two years. I support the work of the board and respectfully ask that you support HB 275 so they can continue their good work.
