FISCAL NOTE ANALYSIS

BILL NO. HB 312

Analysis

This legislation would allow a peace officer to arrest a person without a warrant if that person has committed a misdemeanor assault at a health care facility and was not seeking medical treatment at the time of the assault or was stable for discharge. The legislation also establishes an aggravator at sentencing if the person committed a felony at a health care facility and knowingly directed their conduct at a medical professional or because of the medical professional's exercise of professional duties.

The Department of Law does not anticipate a fiscal impact.
