Greetings,

Thank you for letting me go over my timeline! Here is my complete testimony:

Good afternoon, This is Edie Grunwald, Palmer, AK. I represent myself.

– I support SB127 and ask that you support it. It is an opportunity – right now – to actually make good on the omnibus bill SB91 that was passed into law. No matter the intent, goals, failures, successes – it is too big and has too many failure points. I support SB127 ; it will be the best way forward at this point. Sponsor a bill that increases sentencing for murder – the added ten years – absolutely need this (thanks!). We really need the option for the death penalty for the worse of the worse violent crimes.

I can assure you, you do not want to be a victim. I do not want you to be a victim.

This is about public safety. My heart goes out to the ones who gotten their lives in order – but, crimes against others need to have punishment first. Many people have experienced trauma as children and make different decisions (including myself). Bettering one's life is always the best path. It's about Personal Responsibility - Please differentiate between testimonies – special interests, those in the industry – from the rest of us who are experiencing and living the negative effects of SB 91.

After my son, David Grunwald (16 years old) was murdered – November 2016, I have been pulled into the justice system and correction system, into activism, and now into politics. None were on my "to do" list.

I have lived in Alaska for 33 years. North Pole, Anchorage and now the Mat-Su.

SB127 fixes some of SB91.

--Experience with SB91 over the last year and a half has proven to make it difficult or impossible for law enforcement and prosecutors to protect the public from reoccurring crime.
-- We are seeing the widespread impact of criminals being released so quickly. Communities are arming themselves and organizing.

-Murder, armed robbery, these really egregious crimes were included in the "SB 91 justice reform." I encourage people think critically. I have been listening to the testimonies repeat

what they've possibly been told. One quick inclusion example: Parole: less time spent in prison before eligible for parole.

- Give Judges back their discretion –
- Restore a bail schedule that is based on severity of the crime and all criminal history. Equality based on social status is not a variable.
- Return to the felony crime levels. Felony crimes are serious and should be treated as such.

Pre SB91 was already liberal. Crime was already a problem. Now it's an invitation for criminals, as we have been experiencing. I was "poo pooed" saying that criminals would come to Alaska because of SB91. Unfortunately, I was right.

I support reform, rehab, and re-entry. Address successful reform, rehab, and re-entry programs in their own bills/laws.

Do the crime, do the time. Criminal activity must have consequences.

For crimes against others – we need punishment first.

-Crime negatively affects the economy. Businesses. Families, insurance, costs.

The people who are opposing SB127 are saying this is too early that SB 91 has not had a chance to work; I totally disagree. No way, no how. It is never too early to save a life or reduce crime. It's okay to make honest mistakes – but let's correct the mistake. Similar to asking for forgiveness – it's about fixing the mistake.

Alaska needs to be substantially tougher on crime and fix some of the gaps in SB91 - thus, I support SB-127.

The crime level is terrible. We are at the top of several national list for crime high crime levels. We must have consequences at the lower crime levels to prevent crime from escalating.

We need punishment for criminal activity. Please represent the people...we need you to make public safety a top priority. SB91, as it stands is "people friendly" but, only for criminals and convicts. We, the law-abiding citizens and victims have been left behind.

- Amendments should include getting rid of geriatric parole.
- All crimes should count toward repeat offenses. It shows a pattern.
- Give Judges judicial discretion back. The Pre-trial tool could work – but only if criminals were honest. We need human judgement.
- Restore the bail schedule.
- Remove the inflation adjustment for theft.

We had a crime problem before SB91. Two of those charged in my son's murder had no consequences in previous criminal acts. Potential criminals must believe they will get caught, and actually have significant consequences.

- Although murder and rape has increased 10 years in sentencing as per SB91, we have to get to that conviction. Meaning that it is difficult to get to the conviction. Plea deals are utilized frequently. * The 10 years for added for murder was already there - with aggravators; So, it is not an excuse to not fix the gaps in SB91. And anyway, we could keep that part of SB91. – Make it a law on its own.

Please improve the recruiting and retention with our AST. So they may fully investigate and arrest. Then fully fund the DA's office.

DUE PROCESS IS ON STEROIDS, WHICH IS FINE, BUT RIGHT NOW, there are crimes going unattended, not prosecuted, and let go. And SB91 affects the sentencing. Example, Linda Ann Martz Bowers murder.

-Parole needs to go back up to more time served before being eligible and even more time for violent criminal acts (and must be earned - not automatic or absolute.

- The Juvenile Justice system needs to be stricter to prevent further criminal activity. Right now there is a culture of "I can get away with anything before I turn 18." It is more likely to reform and address reentry for less likelihood of recidivism as adults.

SB 91 is absolutely soft on crime and soft criminals and SB91 is hurting all of us and putting so many people at risk.

Thank you! Thank you to those of you who represent your constituents and realize your actions affect all Alaskans. Be tough.

Have courage. Please support SB127 to start getting a handle on crime. Our citizens are talking, they have a lot to say and I ask you to please listen. Pass SB127.

I have lived in Alaska for 3 years, in eagle River for all 3. When I first moved here, it was a pleasant safe place to live, we loved it! We considered making Alaska our permanent home once we graduated collage. But now, for the first time in my life, I feel unsafe in my own home. I worry for my safety and the safety of my children. We have 5 open cases with apd, 5 that all happened in the past month! I understand apd is busy but this is just unacceptable. Maybe all the pfd money that is being taken from us should go straight to apd so we can at least sleep at night. I would honestly be happy to give up my full pfd if it meant the crime would go down significantly.

Over the past month we have lost over \$6,000 in personal belongings to theifs(unrecovered), we had a vehicle stolen (now recovered thanks to a bystander and apd), we have had swat present in our cul-de-sac multiple times, we have heard gun shots and domestic disputes.

I know times are tough and there is a lot on your plate, but I urge you, as my elected offical, to please fight for me. Fight for me and others in my community who feel unsafe, who contribute to society in good ways only to have our possessions stolen and our family's in danger. As crime continues to rise more and more good people will leave and criminals will prosper. We have to stop it now.

Repealing sb91 seems like a possible good start, but it will not be enough.

I am grateful for the opportunity I have to live in this amazing state, it's beautiful and aside from the criminals, it's a wonderful community! I'm ready to fight for it. Let me know what I can do to help you make our community safer.

Public Testimony about SB127;

I am absolutely opposed of SB91 and I am for a full repeal of it. Meanwhile I am in support of any bill that will curb it, such as SB127. Again, I support SB127.

First I want to thank good politicians with a positive motivation like Amy Demboski and Mia Costello.

Second of all I want to urge you to look at the difference between testimony of private individuals and the testimony of those representing special interest groups. You will notice that largely in general testimony of private individuals is against SB91 while the testimony of those in favor of SB91 is either from those directly benefiting from it or representing special interest groups that in turn directly benefit from it. As politicians your responsibility should lie with the private citizens and not with special interest groups that run on taxpayers dollars.

Also please keep in mind that citizens may have to worry about going on public record against SB91 as they may have to fear personal retaliation by criminal gangs that directly benefit from SB91. The criminals have become so ruthless and reckless that that kind of action would not be surprising at all.

I fear for the safety of my family, my wife and my daughter! - I have to fear for it everyday. Every time we leave the house we have to wonder if it will be broken in and burglarized when we get back. We already moved once before out of a neighborhood that "turned bad". Will SB91 continue until there are no good neighborhoods left?! - I think that is already the case right now! Many crimes do not get reported because people fear that their insurance will go up and that the value of their house will drop like a rock. I bought my house while the economy was still good, I could not even sell it now and even get back out of it what I still owe the bank for it. So leaving again is not an option. While we were gone a break-in was attempted and thankfully the good neighbor across the street chased them off.

Your politics have caused so many to lose their jobs and so many had to leave the state already. Meanwhile with SB91 you are causing a steady import of criminals from the lower48. These people clearly see the difference between communities that are tough on crime and this abortion of a law that SB91 is.

It would be ok if you could keep the drugs out of the prisons, but you cannot even do that ! As you obviously cannot even keep the drugs out of the prisons, how is any of this SB91 supposed to work?

It doesn't work and it hasn't worked and I believe you cannot show any place in the nation where this "soft on crime" approach has worked.

I am absolutely disgusted at people claiming the crime problem is not real and only perceived because of social media etc... I think its disgusting that people testify and say that there would be no problem if we that complain against SB91 would volunteer to work with criminals and addicts.

Dear members of the Senate Finance Committee,

I am writing to express my opposition to SB 127. As you all know, there was a tremendous amount of research and work done by the Alaska Criminal Justice Commission prior to the adoption of SB 91. Our legislature should not be making large policy decisions based upon anecdotes or fear, but should be basing decision upon data and evidence discovered after research and deliberation. SB 91 has not caused an increase in crime in Alaska. Crime was rising prior to SB 91 and the addiction issues that are ravaging our communities were not caused by SB 91.

Although I could not call in to today's hearing due to other obligations, I have been able to listen to some of the testimony. One thing that strikes me is that there are many in the community that don't actually know what SB 91 did and what laws were actually changed. Daily, I read comments on-line from community members that blame SB 91 for crimes that were not at all impacted by SB 91. Violent crimes like murder had penalties increased by SB 91. Robbery is not now a misdemeanor. Carjacking is not considered the same as a low-level theft. I urge you all to really review and understand the benefits of SB 91 and not be swayed by misinformation.

Repeal of SB 91 is unnecessary. If fixes are needed, as they were prior to SB 54, the legislature can fix those issues as required. SB 91 has many, many important provisions that only recently went into effect. We cannot evaluate the effectiveness of SB 91 in such a short period of time.

Part of the plan behind SB 91 was to reinvest money in treatment and re-entry programs. Once we do that, we can make our state more safe and we can evaluate the effectiveness of SB 91. The old way of operating in our criminal justice system did not end crime or reduce crime. Instead, it drove up costs beyond that which was sustainable. If we repeal SB 91, our prisons will continue to overflow and we will need another \$200+ million to build another one. And that \$200+ million will do nothing to make our communities more safe. Instead, people will be released after lengthy prison terms and without the services needed to keep them from re-offending. Repeating the mistakes of the past will perhaps placate some of the public, but it will not stop crime or reduce crime and we will not be any safer than we are today. In fact, if the past tells us anything, it tells us that we will be less safe.

SB 127 is not going to stop crime and it's not going to solve addiction issues. If there are parts of SB 91 that need revision, then please address those, as you did through SB 54.

I have lived in Alaska for most my life, growing up on the Kenai Peninsula. I now reside in Anchorage with two children and my significant other. I am absolutely heartbroken and fearful of the increase in crime the past few years, but most importantly since the implementation of SB91. I listened today to Alaskans, who were associated with organizations across our great community and have a vested interest in keeping SB91. I do not represent an organization, an advocacy group or other. I represent myself, my family, my friends and my colleagues who seem to talk on a daily basis about the new crime of the day, the week and the month. How tragic, absolutely tragic and devastating and rampant the crime in our state has become. Anchorage especially, has become a crime ridden community. Yesterday, as I stood outside my vehicle near the Dimond Center Mall, my heart raced in fear for the people walking towards me. Not because they would in fact do harm to me, but because they could, without consequence. I dare not enroll my children in daycare centers which do not have security or locked doors that require passcodes for entry, for fear of those who may enter the building. I do not dare take my children for a Sunday drive, for fear of being in the wrong place at the wrong time. I wake each day to a new story about a murder, a car jacking, a robbery. How can you allow your community, your state and your constituents to live this way?

As a person who was burglarized six months ago, I despise and resent the fact, that I was told by the police officers, who came to investigate 'apparently wasting their time and my taxpayer money' that due to SB 91, their hands were effectively tied. As a conscientious citizen, my wife and I personally 'tracked in fresh snow' and took the officers to the location where the tracks lead from my garage to the burglars home, a few blocks away. Even with evidence leading from my home to their's, the officers informed me that due to this bill they had basically been castrated. They told us at that time, it was even known as a drug house! I personally looked up these residence in the Alaska legal system, and found that each of them had multiple counts and convictions against them! We spoke to the neighbors, who openly told us they were afraid of the goings on in that house. One neighbor even had video surveillance to protect his home from specifically these people. His video submitted to the officers showed on tape, these people coming and going, with bags of items, within the timeframe of our burglary. But we were told the best that we could hope for was to catch them selling my items. Even at that officers said they would be released with no more than a slap on the hand.

Who is responsible for this insanity! Wichever lawmakers came up with this delusional idea, to lower the inmate count, and reduce legal costs should go to jail themselves. But I suppose that wouldn't happen because those people are above the law. This SB91 law has planted the perfect storm for vigilanteism, because the law abiding public is only going to take so much for so long until they rise up. You think we have a problem now? Wait till that day comes! As to the outcome, six months later, I have no answers on my case. The finger prints taken from our home haven't even been run through the system of 'known criminals'. But the people who did this crime come and go freely, with no fear of judgment or incarceration. Why wouldn't these people commit crimes? Sounds like the type of people you would love to have walking our street freely, right? Meanwhile, myself and my family, have to wait in fear for another burglary behind my locked doors. Who is the victim here?!?! Who has rights? It is obvious the law has now given criminals more rights than I have. Don't be deceived, there is a rising coming if you don't make laws that punish criminals, instead of turning them to the street freely!
