## NOTES

- <sup>1</sup> With few exceptions, all commercial fishing activities in state waters must be associated with a properly CFEC licensed vessel and permit. [AS 16.05.490-530](#).
- Either USCG documentation or state registration is required for all motorized vessels used in commercial fishing activities.
- Vessel registration must be renewed annually, and fees are assessed based on the USCG definition of length. [46 USC § 2101\(20b\)](#).
