Dear Committee Members:

Unfortunately, I am unable to attend the public hearing today on SB 89. But I urge you to NOT PASS this bill. The existing rules regarding sex education allow parents to opt-out of the program if they object to the materials being presented in their child's school. The parents have control. This should remain an opt-out program and not be changed to an opt-in. The students most in need of this kind of education, which can help avoid child abuse, unwanted pregnancy, sexually transmitted diseases, and sexual assault, are precisely those least likely to receive parental permission.

This bill would also prevent Planned Parenthood from assisting with the curriculum. Planned Parenthood has the most comprehensive and age-appropriate education for children. There is overwhelming proof that comprehensive sex education delays sexual activity in teenagers, reduces the incidence of teen pregnancy and the spread of sexually transmitted diseases, and reduces the incidence of sexual abuse of children. Have you reviewed the material that Planned Parenthood presents? What is it that is so objectionable? I personally support Planned Parenthood, but why not allow each school district to determine what curriculum to use and who is best suited to provide that information? Why take that control away from the school districts?

I hope my concerns will be taken into consideration as you debate this bill.
