

I am a concerned lifelong Alaskan in Anchorage. I believe we must use a portion of the Permanent Fund earnings to help close our current budget gap. This does not have to be a permanent solution. Tell constituents that this is not a permanent change. Add language into the bill that states that if State Oil and Gas revenues increase to a sustainable level that using PF earnings will stop.

I would rather see all of the Permanent Fund Earnings be used to cover the budget gap (no PFD) than any additional taxes be added, although is not likely the best decision for Alaska's poor.

My suggestion, cap the PFD for 2017 at \$800 or \$1000 per person and use the rest to cover the budget.

Also, taxing Alcohol and Tabaco to the extent that we have the highest Alcohol and Tabaco taxes in the nation is unacceptable. These taxes hurt Alaska's poor the most. These taxes are also unlikely to decrease consumption of either. Poor Alaskan will just use more of their incomes to pay for Alcohol and Tabaco.

Dear Finance Committee,

It appears that in the recently passed budget, the Legislature is planning to fund government out of the CBR again this year.

Surely that's not the final plan! I cannot think of a worse idea. The math is simple. Many people complain about new taxes or cuts or restructuring the permanent fund, but nobody actually disputes the numbers.

The fact that many voters don't like reality doesn't excuse the Legislature from their sworn obligation to deal with reality.

If you don't muster the political will now, we will all pay the price in the form of a major economic crash. That's not a Chicken Little prediction, it's very basic addition and subtraction.

My husband and I are successful professionals and homeowners with children in the public schools. We'd like to stay in Alaska, invest in our property and business interests, and do our part to help the state prosper. No way are we investing a red cent in anything unless the Legislature passes a real budget that doesn't just kick the can down the road. And there are many others like us. Please do the following:

- Raise revenues in the form of income tax, sales tax, or both. The free ride is OVER whether people like it or not. There is zero evidence to suggest that oil prices and production will recover enough to cover the gap in the next decade. Zero. I'm happy to pay for services that my community enjoys. I don't expect freebies.
- Restructure the Permanent Fund. "Saving" our dividends in their current form is not an option. You know as well as I do that they'll be gone after the 2017-18 budget anyway - the CBR will not pay for another year.
- Cut spending. There are still cuts to be made without abandoning law enforcement, infrastructure, and basic humanitarian function.

The reality is unpleasant, but if we miss this last-ditch opportunity to deal with it, it will be even more unpleasant. You've been elected to govern with knowledge, facts, and wisdom, not to do whatever is most popular at any given moment.

Please know that there are many of us who will fully support you to take an unpopular position that will save our state in the long term. I beg you to join the ranks of great statesmen, like Jay Hammond and Ted Stevens, who put Alaska's future first.
