When developing or constructing a connecting line, the Alaska Gasline Development Corporation shall, to the maximum extent feasible, use existing land, structures, real or personal property, rights-of-way, easements, or other interests in land acquired by the Alaska Gasline Development Corporation or the Alaska Natural Gas Development Authority."
