



# Alaska Oil & Gas Conservation Commission (AOGCC)


- Quasi-judicial State regulatory agency
  - Oversight for underground oil & gas operations
    - Private and public lands in Alaska
    - Exercises police power of the State

1. Regulate drilling and development of oil, gas & geothermal resources
2. Regulate underground storage of natural gas
3. Ensure Metering accuracy for custody transfer


# AOGCC Mandate

- Prevent waste of energy resources (Oil, Gas, Geothermal)
- Promote greater ultimate energy resource recovery
- Protect underground fresh water from damage caused by oil, gas, and geothermal operations
- Protect human safety
- Protect correlative rights




# Development Timeline for North Slope Oil Fields




# Daily Oil and NGL Production (1960 – 2011)

# Alaska 2011: New Wells and Wellbores\*




# Daily Oil and NGL Production (1970 – 2011)

with Average Nominal Price of U.S. Crude Oil, First Purchase\*\*




# Exploratory Wells and Wellbores Drilled & Planned (1950 – 2012)\*

## North Slope Oil and Gas Only














# Alaska's Active Drilling and Workover Rigs (2006 - 2011)



# Alaska's Active Drilling Rigs (2006 – 2011)




# Alaska's Active Workover Rigs (2006 – 2011)




# Workover Activity by Type (2003 – 2011)\*


