As a lifelong, multi-generation Alaskan, wife, mother and active community member in Fairbanks, I urge you to approve House Bill 17, "an Act adding to the powers and duties of the State Commission for Human Rights; and relating to and prohibiting discrimination based on sexual orientation or gender identity or expression." Please pass it out of the Judiciary Committee on Monday.

Alaska must live in the 21st Century when it comes to LGBTQ protections against discrimination, similar to what we've done with religion, race, color, etc. Alaska used to be ahead of the curve on these type of issues, but we've fallen far behind. This has a negative effect on our economy, as we need everybody to help move our great state forward into the future. We need to embrace and welcome all people and not relegate some as "lesser valued" simply because of who they are.

Alaskans have always judged each other based on what we can do and what we contribute to our communities, vs. who we are, what religion we practice, the color of our skin or who we happen to love or how we see ourselves. Did you get out fishing, hiking, fill your freezer with salmon this summer? Did you plant a garden or build a house? Do you have a job, friends and family? Did you run the Iditarod? I am a 79 year old lesbian living in Eagle River with my wife of 44 years. We both taught in the suburbs of Chicago for almost 35 years and were well regarded educators and coaches. My wife also served as assistant principal for 2 years. We moved to AK in 2003 after we retired and served the Anchorage community as volunteers.

During my lifetime, we were classed as mentally ill, could be arrested for wearing clothing of the opposite sex, gay men blamed for the AIDS epidemic, couldn't serve in the military if openly gay, couldn't adopt children, and couldn't marry until 2016.

While rights in Anchorage are protected under the non-discrimination ordinance, we can now marry and live openly, but outside of Anchorage, Juneau, Sitka, and Ketchikan, people can still be fired and denied housing for being LGBTQ.

We are respected, productive members of the general community and should have the same protections of rights regardless of where we live in Alaska. We have fought for our rights basically our whole lives and would love to live knowing that we have equal rights in all of Alaska.

My name is Michael Szidloski and I am a resident of Fairbanks Alaska, and I urge the committee to pass HB17. Similar legislation was set to pass in the Fairbanks Borough, but was vetoed by the mayor for a woefully inadequate reasoning: He wanted it to go to a vote of the populace. Historically speaking (and I let his office and him know this), minority protections have *never* been put to a vote of the people, but rather have had legislation moved forward to protect them. From emancipation of slaves, to voting rights for women, to inter-religious and inter-racial marriage, to gay marriage rights and now to trans rights, legislation protecting the rights of the minority have been the norm.

Codifying these protections enjoyed by almost every other group into State law is an important and relevant step to providing equity and equality in the state. I have several friends who are trans, who have good jobs and are productive members of society, why should they have to fear that their leases may be upended out from under them merely because they're trans? Do we really want to backslide, and allow this type of action against minority groups? I'm a 30-year Alaska resident. Since the 1970's I have worked for LGBTQ human rights. Quite a ride. As an 80 year old, I am sorting my saved articles and photos showing our perilous Alaskan LGBTQ journey. Preparing to donate them to museums.

Shocking to review our Alaskan LGBTQ history and the arguments that hostile groups have dreamed up about us. Remember the Juneau gay men sent out of town with one-way ferry tickets. No newspaper coverage.

Remember Anita Bryant, the Florida Orange Juice Queen and her Save The Children....from gays.

Now we really do need to save the children....save the Alaskan trans children from our State legislature ganging up on Alaskan trans girls to prevent them from competing in sports.

All kids agonize over their differences, and ALL Alaskan kids will be harmed by public scrutiny about their genitalia and threatened physical exams.

Currently many state legislatures flare like a cobra with anti trans bills. Think-tanks have dreamed up this new way to target Alaskans - cut trans girl athletes from any competition. Cruel. And our Senate now considers SB 140. 4 hours of public testimony on this cruel bill last Saturday.

Most Alaskans do not want trans girls harmed by SB 140. The majority of Alaskans support us LGBTQ. Time to pass HB 17 out of committee.

Sports helped me get through my schooling. I was shy and unconfident. Field hockey taught me teamwork, hard work, gave me friends and resilience.

Trans athletes competed at the Rio and China Olympics. No problems surfaced. Trans women have been competing for years around the globe. And now the Iditarod. Not many trans winners. Trans girls have not taken over women's sports. No problem here.

A recent and very sad example of Alaskan anti-LGBTQ discrimination: the State of Alaska wrongly denied PFD benefits to same-sex military couples and their kids....for 5 years. From 2014 to 2019. The state got caught in 2019.

More details on this discrimination by AP reporter Mark Thiessen, April 2019, and in my opinion piece in the ADN. Unknown number of Alaskan parents and kids lost their PFDs for 5 years.

I am proud to be a retired State worker but horrified that State officials violated LGBTQ rights FOR 5 YEARS.

Political think-tanks want to make people frightened. Frightened voters will make sure to vote, and frightened people can be made to do anything.

Alaskans are not buying buy this divisive tactic.

As Matthew Shepard's parents, Judy and Dennis, said when they spoke in Juneau, "It's a new day." After their gay son was beaten and hung on a fence to die, they tour the country speaking to parents. As I am sure you are aware, American youth and young adults who identify as LGBTQ face a 120% greater chance at becoming homeless because of lack of family support (Morton et al., 2017; Morton et al., 2018). Additionally, youth from this population have a higher suicide rate and are bullied more often at school than their cis-gender and gender conforming classmates (U.S. Department of Health and Human Services). Passing HB 17 sends precedence to our youth, that they can grow up in an environment where they will not be discriminated against on the basis of their sexuality, gender identity, and gender expression.
