Dear Members of the House Judiciary Committee,

I'm writing to support preserving the railroad right-of-way that enables the Fish Creek Trail connection.

I've lived near the proposed connection for about 20 years and regularly walk and bike in this area. This short segment would meaningfully improve neighborhood connectivity to the Coastal Trail, create useful walking and biking loops, and provide a direct link to the Fish Creek Trail, which is a really great trail and heavily used.

The project has strong public support, a \$1.75 million local match, and roughly \$15 million in federal funding attached.

Whatever the merits of HB 136 as a property rights and fee policy bill, it should not introduce legal uncertainty that allows a small number of adjacent owners to block or delay a public transportation use that benefits the city as a whole. If HB 136 moves, please include clear language preserving the ability of DOT and the Municipality to build public trails within the railroad transportation corridor when designed to avoid adjacent private land and when they do not unreasonably interfere with railroad operations.

If that protection is not included, I encourage you to hold HB 136.
