# **Program Context**

# Rural Health Transformation Program (RHTP)



Authorized through the budget reconciliation process (H.R. 1)



\$50 Billion allocated over 5 years



Alaska awarded \$272 Million for year one

2<sup>nd</sup> highest allocation

Monies may be “clawed back” if states fail to meet deliverables

- Tribal Health Organizations
- EMS

- State agencies



Entities across Alaska can apply for RHTP funds.



# **Evaluating the Opportunity**

# Breaking Down the Challenge

## 5 tranches of funding

- 1 year to obligate funds (DOH)
- 2-year spend window (providers)

## Typical tranche timeline and intersection

- 10/1/2026 FFY 2027 begins
  - **Tranche 1** spending obligated (all awards issued)
  - **Tranche 1** recipients have one year left to spend
  - **Tranche 2** award announced for Alaska
  - **Tranche 2** DOH initiates award process

# Clock Has Been Ticking

- **Tranche 1 award announced December 31, 2025**
- **Clock started October 1, 2025**
  - Tranche 1 funds must be obligated within next 7.5 months
    - ✓ **Grant system** must be stood up
    - ✓ **Solicitation for proposals** must formally go out
    - ✓ **Applications** must be drafted and submitted
    - ✓ **Scoring**, award **decisions**, funding **distribution**
  - Tranche 1 spend window is already down to 19 months today
- **Doesn't mean rush, be very careful with delay**

# Federal Limitations on RHTP Funding

## **Construction of new facilities or building expansions**

- Who answers project specific questions about whether costs are eligible?

## **Supplanting existing funding**

- Do payment and care delivery models require waivers by CMS? How long will that take?

## **Broadband infrastructure, internet installation, certain telecom equipment**

- Reality check: can we achieve technological transformation without the basics?

## **Constraints on multiyear projects**

- With the 2-year spend windows, how are awards considered for 2+ year projects?

## **Indirect costs**

- Are the limitations on a per project basis or disallowed in totality?

## **Future Awards and Clawbacks**

- How will future tranches be calculated and will \$272 million hold into the future?
- How much will be clawed back if the policy initiatives are not achieved? Is it a per policy \$?
