Dear Chair Olson and Members of the Labor and Commerce Committee

I am writing to urge your support for HB 30 which is scheduled to be heard by the House Labor & Commerce Committee Wednesday.

The Anchorage School Board supports a return to a defined benefit plan for public employees. I believe the current defined contribution plan makes it more difficult for us to recruit employees. Anchorage continues to need to make a major effort to recruit teachers and other qualified employees to fill positions within the Anchorage School District. We will not lower our standards to accept less than well qualified employees, but we can not find enough people in Alaska to fill all of our positions.

Even more serious than the recruitment issue is the question of retaining our best employees. These employees are the ones most able to move to another state to find comparable employment. Many will choose to do that in order to obtain the security of a defined benefit pension. Those in TRS have a particularly strong incentive to do so since they do not qualify for social security benefits. Public employers spend a lot of money recruiting and training employees. It would be a shame to have the best employees take that training to another state, but that is exactly what they are encouraged to do under a defined contribution plan.

Alaska originally moved to a defined contribution plan under a belief that it would save money and help ease the deficit in the pension fund trust balance. We have since learned that those assumptions were incorrect. There is no longer a financial justification for not returning to the defined benefit plan. Returning to a defined benefit plan will put us on a more equal basis with other states for both recruitment and retention. Please support HB 30.

When the legislature created the defined contribution retirement tiers, it did not have all of the data that it needed. Now the current actuary states that the new tiers are not saving the State of Alaska any money. PERS tier III and TRS tier II had already corrected projected short falls to the trust fund.

There were two other problems. First, the previous actuary made gross mistakes and the State of Alaska is now suing for over \$1 Billion. The other problem was the way that the Department of Administration managed the billings to employers. Management should be transferred to the professionals in the Alaska Retirement Management Board, but that is another issue.

Worst of all, new employees coming into the defined contribution tiers won't have secure and safe retirements. They are being punished, if you will, for others mistakes. You can remedy this by passing HB30. Please pass HB30.
