ANALYSIS: (Attach a separate page if necessary)

A Farm-to-School program as outlined in Sec. 2 of HB 70 would be created in the Division of Agriculture to work with the Department of Education and Early Development, School Nutrition Program to increase procurement and use of Alaskan grown food in the public schools. A Development Specialist, Range 18, \$81.5, in conjunction with a part-time Agricultural Inspector, Range 16, \$30.5, would implement Sections 2, 5 and 6. Travel expenses will cover travel to remote districts to educate students on the benefit of growing and consuming local produce. Contractual services will cover cost of curriculum coordinated with the Department of Education to educate youth on the benefits of growing and consuming local produce. Section 8 of the bill repeals the Farm to School program on July 1, 2013 (end of FY 2012).
