Changes to from HB-3 (FIN) Version 26-LS0008\A to Committee Substitute (FIN) Version 26-LS0008\P

HB-3 An Act relating to issuance of identification cards and to issuance of driver's licenses

Released: March April 2, 2009

New Text Underlined [Deleted Text Bracketed]

1. Title Change to HB 3 Version P

Page 1, Line 2 of Version P the following language was added:

Example:

"An Act relating to issuance of identification cards and to issuance of driver's licenses; relating to regulations concerning identification cards and driver's licenses; and providing for an effective date."

Explanation: Will be given by Jerry Luckhaupt.

The title was changed because of the new Anti-Real ID Language that was added to Committee Substitute Version P by the Bills Drafter Jerry Luckhaupt 465-6661.

2. Change from [(i)] to (l) in Version P

Example:

Page 1, Line 9: it is for identification purposes only. Except as provided in (g) and [(i)] (l)

Page 2, Line 1: Except as provided in [(i)] (1) of this section, an identification card issued to a person

Explanation: Will be given by Jerry Luckhaupt.

3. Change of expiration date for ID Cards issued to persons 60 years or older

Page 2, Line 1 of Version A the word [eighth] is deleted and replaced with $\underline{10^{th}}$ on Page 2, Line 2 of Version P.

Example:

Except as provided in [(i)] (1) of this section, an identification card issued to a person who is 60 years of age or older expires on the person's birthday in the [eighth] 10th year following issuance of the card.

4. Anti-Real ID Language related to identification cards

Page 2, Line 27-29 of Version P the following language was added

Example:

(m) The commissioner of administration may not adopt a regulation related to identification card solely to bring the state into compliance with the requirements of the federal REAL ID Act of 2005 (P.L. 109-13, Division B).

5. Anti-Real ID Language related to driver's licenses

Page 2-3, Lines 30-31 and 1-2 of Version P the following language was added

Example:

*Sec. 4. AS 28.05.011 is amended by adding a new subsection to read:

(c) The commissioner of administration may not adopt a regulation related to driver's licenses solely to bring the state into compliance with the requirements of the federal REAL ID Act of 2005 (P.L. 109-13, Division B).

6. Anti-Real ID Disclaimer Language

Page 5, Line 15-17 of Version P the following language was added

Example: NO COOPERATION WITH FEDERAL REAL ID ACT. This Act may not be construed as support for, or cooperation with, the Federal REAL ID Act of 2005 (P.L. 109-13, Division B).
