DPS Training Academy

- 124,049 calls for service
- About 10% result in criminal cases
- 10 Homicides in 2009, 100% solved
- 78 open cold cases, 30 cases have been solved 11 have resulted in arrests for 1st degree murder, 14 are actively being worked
- Killers of Toni Lister (1982) and Bonnie Craig (1994) are going to trial.
- Killer of Scott Coville (1988) indicted and extradited last month.
- Marijuana grow operations and meth labs continue to decline, but Heroin, and meth importation cases are filling the void.
- Alcohol importation arrests decreased by over 26%. 218 arrests made
- 377 Sexual Assaults and 321 Sexual Abuse of Minor cases
- 64,731 Prisoner transports, 8,186 Arrest Warrants served or closed, 13,796 Writs served or closed
- 770 SARs, 317 Saves
- 63 highway fatalities, 16 alcohol related
- 13 of 15 new federally funded PCN's vacant
- 11 Applicants just received hiring notices to begin the Academy 2/22/10

- As of January 1st ; 70 of 71 funded positions were filled.
- 13 VPSO's are currently at Academy
- VPSO Advisory Working Group
- Study; 40% reduction in the rate of serious injury from assault in communities with VPSO or VPO
- Prosecution for SA is 3.5 times higher in communities with VPSO or VPO
- Governors commitment to place VPSO's in communities. 15 Per Year
- Turnover rate is improving; FY07=29%, FY08=35%, FY09=14%
- VPSO recruitment video completed
- Rural Grants – equipment, supplies and training
- Trooper Support - Village visits 3659
- VPSO's investigated 3,937 incidents

- Fire Deaths: 24 in 2007, 19 in 2008, 22 in 2009.
- 1543 Inspections (68% increase over 2008) with compliance at 38%.
- 1249 Plan reviews (18% Increase over 2008)
- 11 deferred jurisdictions, audited every 2 years. Ketchikan will be added next month.
- Web based portal for plan review operational.
- Fire and Building Officials Forum - 2nd annual was held in April.

- Fingerprint background backlog was 13,000 with 150 day turn time. This was eliminated and current turn time is 10 days.
- Challenge; Digital Network Storage and migration to new technologies

Crime Detection Laboratory

- Office of Professional Standards (OPS) is fully operational.
- Software tool now in place for managing citizen complaints and internal investigations. Also tracks uses of force, pursuits, and employee commendations.
- Web link in place for public reporting of employee conduct directly to OPS.
- Training & Certification is offered to 6100 career firefighters and volunteers
- CDVSA funding to 24 Victim Service Programs across Alaska; 8000 victims served
- Funded 81 DV/SA Training sessions for Law Enforcement, Advocates, Prosecutors, First Responders, Court Personnel
- Focusing on strategic planning to boost DV/SA prevention activities at local and state levels

Evidence

- 4064 cases submitted -70% turned in 30 days or less.
- Cases over 120 days old, reduced by 50%
- Case backlog currently 520
- 50% reduction in biological screening backlog
- Designed a new sexual assault evidence collection kit
- 40% of suspect submissions are exonerated by DNA results
- DNA-CODIS samples backlog of 9000 eliminated. 15000 samples worked in FY2009
- ASCLAD Lab Legacy accreditation renewed. ISO9000 requires ASCLAD Lab International by next January.
- Challenge - Lab space. Built in 1988 to accommodate 23; currently have 40

- Backlog of property crime cases waiting DNA analysis remains unchanged
- Submissions for property crime DNA is down 75%
- Implemented laboratory information management system (LIMS)
- Cross training DNA Database Analysts to work DNA Casework
- Lab is currently developing the needed science to perform y-STR, Mitochondrial DNA and Low Copy DNA
- Existing lab facility incapable of supporting Mitochondrial and Low Copy DNA
