

## ***Sample Home Energy Voucher Language for HB 278***

### **Pre-Work Authorization**

Alaska Housing and Finance Corporation guarantees up to \$\_\_\_\_\_ for the home energy efficiency work to be completed at the property located at \_\_\_\_\_ and owned by \_\_\_\_\_.

The actual amount of payment by Alaska Housing Finance Corporation is determined by the increase in home energy ratings by comparing the pre and post-improvement energy audits, and capped at \$10,000.

If the amount of the expenditures for the improvements exceeds the amount of the reimbursement authorized by AHFC, the amount owing shall be the sole responsibility of the homeowner.

In any case, the vendor's sole remedy is to pursue payment from the homeowner.

## **Post-Work Payment Authorization**
