SUBJ: Request for Hearing – CSSB 248 (L&C)

I would like to request a hearing for this bill, which would extend the termination date of the Board of Marital & Family Therapy to the year 2014. According to the legislative audit for this panel, there were no issues discovered adversely affecting the public, but auditors commented that the Board's desire to reduce its deficit has kept it from making necessary and timely changes to its regulations. They also felt that the Administration needs to improve support for this board and make more timely appointments.

The Committee Substitute was generated because the original bill was drafted for the number of years in the last extension exercise, which was different from the recommendation in the audit. Once staff studied the audit, we asked for a CS for the bill to conform to that audit.

SB 248 is attached, as well as the CS. The bill is its own sponsor statement and sectional analysis, but attached is the legislative audit. There is a fiscal note from DCCED accompanying SB 248, also attached.
