1 * **Sec. A. DEPARTMENT OF LAW.** (a) The amount necessary for the purpose, not to
2 exceed \$12,443,959, is appropriated from the general fund to the Department of Law to pay
3 the principal of the award of damages entered against the state in Donald H. Carlson, et al. v.
4 State, Commercial Fisheries Entry Commission, 3AN-84-5790 Civil (Anchorage Superior
5 Court).

6 (b) The amount necessary for the purpose, not to exceed \$7,029, is appropriated from
7 the general fund to the Department of Law to pay the costs entered against the state in Donald
8 H. Carlson, et al. v. State, Commercial Fisheries Entry Commission, 3AN-84-5790 Civil
9 (Anchorage Superior Court).

10 (c) The amount necessary for the purpose, not to exceed \$7,482,569.73, is
11 appropriated from the general fund to the Department of Law, to pay the award of attorney
12 fees entered against the state in Donald H. Carlson, et al. v. State, Commercial Fisheries Entry
13 Commission, 3AN-84-5790 Civil (Anchorage Superior Court).

14 (d) The amount necessary for the purpose, not to exceed \$62,356,738, is appropriated
15 from the general fund to the Department of Law, to pay the interest on the principal of the
16 award of damages entered against the state in Donald H. Carlson, et al. v. State, Commercial
17 Fisheries Entry Commission, 3AN-84-5790 Civil (Anchorage Superior Court).

18 (e) If the amount available for appropriation from the general fund is insufficient to
19 fully fund the appropriations made in (a) - (d) of this section, the amount necessary to fully
20 fund any of the appropriations made in (a) - (d) of this section is appropriated from the budget
21 reserve fund (AS 37.05.540) to the Department of Law for the purpose specified.

22 (f) It is the intent of the legislature that the Department of Law administer the
23 appropriations made in this section in a manner that minimizes their expenditure.

- 1 * **Sec. B.** LAPSE. The appropriations made in sec. A of this Act lapse June 30, 2014.
- 2 * **Sec. C.** Section A of this Act takes effect immediately under AS 01.10.070(c).

1 * **Sec. A.** FUND TRANSFER. The proceeds from the sale of loans by the Alaska Energy
2 Authority to the Alaska Industrial Development Authority under a memorandum of
3 understanding dated February 17, 2010, estimated to be \$20,600,000, are appropriated to the
4 power project fund (AS 42.45.010).

5 * **Sec. B.** CONTINGENCY. The appropriation made in sec. A of this Act is contingent on
6 passage by the Twenty-Sixth Alaska State Legislature and enactment into law of a version of
7 SB 301.

8 * **Sec. C.** LAPSE. The appropriation made in sec. A of this Act is for the capitalization of a
9 fund and does not lapse.
