**BILL NO. CSHB 128(TRA)**

**Analysis**

HB 128 prohibits a person under 18 years of age from driving on a highway or vehicular way while using a cell phone. It is an infraction. A law enforcement officer may not stop a minor solely for using a cell phone, but only if the peace officer is otherwise authorized to stop the vehicle may the person be cited.

Passage of this legislation would have no foreseeable fiscal impact on the Department of Law.
