# **Division History**

- 1978 creation by statute AS 16.05.090
  - Duties (7) are found in AS 16.05.094.
- 1980 federal passage of ANILCA.
  - Rural residents given priority.
  - 1989 Alaska Supreme Court ruled this a violation of Alaska Constitution.
- AS 16.05.258 Subsistence use and allocation of fish and game.
  - 1986 passage.
  - 1992 passage.



#### Division Mission


- To scientifically quantify, evaluate, and report information about customary and traditional uses of Alaska's fish and wildlife resources.

    - Confidentiality.







## Research Update



A successful moose hunt, Chalkyitsik, Alaska, 2009.

Target: conduct a minimum 5 studies in at least 3 of 6 regions at a 5-year average.

• In FY10, 15 community surveys were completed, below the target of 26 communities (5-yr avg) due to ongoing multi-year research; this target has been met 3 of the past 5 years.

Targets were exceeded in 2 of 6 regions, below overall target.


Division's Technical Papers are posted to the Division website and sent to the Alaska

- 13 Special Publications, deliberation materials, and oral reports developed for these processes.
