
HB 323: Grants for Nonattainment Areas











Questions from last hearing 3/13/12

- Are there any other states that have programs similar to what HB 323 will establish?
 - Libby, Montana received EPA funding to convert wood stoves from 2005 to 2008
 - Spokane, Washington established a wood stove change out grant program funded by the state of Washington to convert non-EPA certified wood stoves.

Questions from last hearing 3/13/12

- Would the energy rater be held liable if their estimate was lower than the final cost of the conversion?
 - Possibly. Since there is potential for the energy rater to be held liable, the intent of the role of the energy rate will be to inspect the currently installed heating unit, confirm the homeowner has a qualified unit for conversion, then submit the approval form to AHFC. The rater will not provide a project estimate. AHFC will then administer a grant for up to \$10,000 to a certified vendor/installer. Upon completion of the conversion, the vendor/installer will submit their payment request to AHFC and receive compensation of up to \$10,000. If the conversion exceeds \$10,000, the homeowner will be responsible for the balance.

Background

- Fairbanks North Star Borough (FNSB) needs to submit approvable plan by the end of the year
 - State Implementation Plan (SIP)
- SIP will include variety of mitigation methods
- Recent air quality control measures report released
 - Provided two scenarios for air quality improvement
 - Multi-fuel control package
 - Wood burning control package

Space Heating Measures – Short Term

- Expansion of existing programs
 - Dry wood
 - Wood stove change out
 - AHFC
 - OWHH retrofits
- Fuel sulfur reductions
- Financial support for cleaner fuels
- Opacity restrictions
- State OWHH standards


