Analysis

This bill establishes a 16 member Workers' Compensation Advisory Council, and abolishes the Medical Services Review Committee. Projected costs are based on estimated travel and per diem charges for meeting twice a year for 3 days each.
The division has \$10.0 in FY2012 budget for two meetings of the 9 member Medical Services Review Committee. The additional members on the new committee will increase the budget requirement from \$10.0 to \$20.0, requiring an additional appropriation of \$10.0.
No additional costs are anticipated for FY2011 because it is not anticipated that council members would be seated this fiscal year.
