FISCAL NOTE #1

BILL NO CSSB 15(HSS)

Analysis This bill would elevate the offenses of furnishing alcohol to persons under the age of 21 (under AS 04.16.051 - AS 04.16.057) if the offense is committed by a sex offender or child kidnapper. For example, if the offense committed under AS 04.16.051 - AS 04.16.057 is a class C felony, the offense would be elevated to a class B felony. Should this legislation pass, the Department of Corrections has data to support an average of 3.5 convictions per year under the following sections: Section 1(2): if the underlying offense is a class A misemeanor, a sex offender or child kidnapper committing the offense is guilty of a class C felony and shall be punished as provided in AS 12.55; 3.5 convictions per year represents an increase of 860 mandays per year @ \$136.44/da = \$117.3/yr Section 1(3): if the underlying offense is a class C felony, a sex offender or child kidnapper committing the offense is guilty of a class B felony and shall be punished as provided in AS 12.55. 3.5 convictions per year represents an increase of 2,579 mandays per year @ \$136.44/day = \$351.9/yr
