- (f) <u>A federal statute</u>, regulation, rule, or order enacted or effective on or after the effective date of this Act <u>is unenforceable in this state</u> if the federal statute, regulation, rule, or order attempts to
- (1) ban or restrict ownership of a semiautomatic firearm or a magazine of a firearm; or
- (2) require a firearm, magazine, or other firearm accessory to be registered.
- (g) An official, agent, or employee of the federal government who enforces or attempts to enforce a federal statute, regulation, rule, or order that is unenforceable under (f) of this section is guilty of a class B misdemeanor and may be punished as provided in AS 12.55.

MY OBJECTION TO THIS BILL HAS NOTHING TO DO WITH WEAPONS.
