



Alaska Pioneer Homes

Total FY14 Budget: \$62.44 million

- GF: \$52.6 million (\$37.2 million UGF & \$15.4 million DGF)
- Other: \$9.2 million (\$5.7 million I/A Rcpts & \$3.5 million SDPR)
- Federal Receipts: \$0.6 million


Increase between the FY05 Mgt Plan and the FY14 Budget:

- Total Funds: \$25 million (66.7%)—An annual increase of 5.8%
- General Funds: \$16.8 million (46.8%)—An annual increase of 4.4%.
 - Salary Adjustments: \$13.1 million GF (78% of the increase)
- UGF increased by \$13.9 million(59.4%) An annual increase of 5.3%

FY14 Authorized Positions: 648

- AK Pioneer Homes Mgmt: 12 PFTs, 1 Temp
- Pioneer Homes: 561 PFTs, 42 PPTs, 32 Temps

Total FY14 Budget: \$62.4 million (\$52.6 million GF, \$9.2 million Other Funds and \$0.6 million Fed Rcpts)

General Fund Growth between the FY05 Mgt Plan and the FY14 Budget: \$16.8 million (46.8%)

- Salary Adjustments (FY05-FY14): \$13.1 million (78% of the increase)
- FY07-FY08 -- Open 18 Bed VA Home in the Palmer Pioneer Home: \$1.7 million GF (10 PFTs and 3 PPTs)
- FY06-FY07 -- Safety & Security: \$1.1 million GF (20 PFTs)
- FY09: Medicaid Waiver Receipts fund change: -\$784.3 UGF (and addition of \$1.5 million I/A)
- FY10: Direct Care Staff funded by a rate increase: \$600.0 DGF (9 PFTs)
- FY12: Medicaid Documentation Requirements: \$400.0 DGF
- FY14:
 - Operational Costs for Contractual Increases: \$460.0 UGF
 - Maintain Current Service Levels at the Pioneer Homes: \$750.0 UGF (Decrement of \$712.0 DGF and \$38.0 I/A Rcpts)

FY14 Operating Budget

Governor's Requests Approved:

Replace Uncollectible Fund Sources for Personal Services Increases: \$57.2 UGF (-\$34.4 DGF & -\$22.8 I/A Rcpts)

Food, Housekeeping, and Laundry Contract Increases: \$460.0 UGF

Fund Change to Maintain Service Levels at the Pioneer Homes: \$750.0 UGF (-\$712.0 DGF & -\$38.0 I/A Rcpts)

Governor's Requests Modified by the Legislature:

Fund Change to Align Funding with Actual Collections: -\$250.0 DGF and 250.0 Fed Rcpts. The Governor requested a fund change of -\$225.0 DGF and \$225.0 Fed Rcpts.
