## FOR AN ACT ENTITLED

"An Act providing for the issuance of one business license for multiple lines of business;

and providing for reissuance of a business license to correct a mistake on the license."

# **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

\* Section 1. AS 43.70.020(a) is amended to read:

(a) For the privilege of engaging in a business in the state, a person shall first apply, <u>on</u> [UPON] forms prescribed by the commissioner, and obtain a license, and pay the license fee provided for in AS 43.70.030. A license issued to a firm for a particular line <u>or lines</u> of business covers all its operations in the state in the line <u>or</u> <u>lines</u> of business regardless of the number of its establishments. A license issued under this subsection must include

- (1) the name and address of the licensee;
- (2) the <u>lines</u> [LINE] of business to be conducted;
- (3) the dates for which the license is issued; and
- (4) the business name to be used by the licensee.
