## A BILL

# FOR AN ACT ENTITLED

- 1 "An Act providing for the issuance of one business license for multiple lines of business;
- and providing for reissuance of a business license to correct a mistake on the license."

## 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

- **\* Section 1.** AS 43.70.020(a) is amended to read:
- 5 (a) For the privilege of engaging in a business in the state, a person shall first
  6 apply, on [UPON] forms prescribed by the commissioner, and obtain a license, and
  7 pay the license fee provided for in AS 43.70.030. A license issued to a firm for a
  8 particular line of business covers all its operations in the state in the line of business
  9 regardless of the number of its establishments. A license issued under this subsection
  10 must include
- 11 (1) the name and address of the licensee;
- 12 (2) the <u>lines</u> [LINE] of business to be conducted;
- 13 (3) the dates for which the license is issued; and
- 14 (4) the business name to be used by the licensee.

- (e) A license holder may request reissuance of a business license to correct an error on the license once during the period for which the license is valid without paying an additional license fee. The expiration date of a license reissued under this subsection is the same as that of the original license.
- \* Sec. 4. The uncodified law of the State of Alaska is amended by adding a new section to read:
- TRANSITION. (a) The provisions of AS 43.70.020(f), added by sec. 2 of this Act, relating to business licenses for multiple lines of business apply to applications for or renewals of business licenses made on or after the effective date of this Act.
- (b) The Department of Commerce, Community, and Economic Development shall develop procedures for persons with multiple business licenses with different renewal dates to consolidate the licenses into one business license with multiple lines of business when renewing at least one of the licenses.
