




People are older when entering the homes




Residents have more chronic conditions

Chronic Diseases Experienced by Pioneer Home Residents vs. National Data




Pioneer Homes Dementia Diagnosis Compared to National Standards


Percentage of Dementia & Related Disease in Alaska Pioneer Homes vs. National Resident




Half way into FY14 and we have already surpassed FY 13's Level 3 admissions.


- » Modernize Pioneer Homes Rate Policy
 - ◆ Rate Policy is Set in Statute: The rate charged need not fully compensate the state for the cost of care and support. AS47.55.030 (b)
 - Update the Rate Policy—Update the Statute
- » Modernize the Pioneer Homes Payor Mix Philosophy.
 - ◆ Medicaid Waiver & Payment Assistance: Two similar programs, that are not aligned. Would require a statutory change. AS 47.55.020 (d)






- » Bring existing homes to maximum occupancy given facility limitations.
