FOR AN ACT ENTITLED

1 **"An Act relating to big bull moose derbies and ice classics."**

2 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

3 *** Section 1. AS 05.15.060(a) is amended to read:**

4 (a) The department shall adopt regulations under AS 44.62 (Administrative
5 Procedure Act) necessary to carry out this chapter covering, but not limited to,

6 (1) the issuance, renewal, and revocation of permits, licenses, and
7 vendor registrations;

8 (2) a method of ascertaining net proceeds, the determination of items
9 of expense that may be incurred or paid, and the limitation of the amount of the items
10 of expense to prevent the proceeds from the activity permitted from being diverted to
11 noncharitable, noneducational, nonreligious, or profit-making organizations,
12 individuals, or groups;

13 (3) the immediate revocation of permits, licenses, and vendor
14 registrations authorized under this chapter if this chapter or regulations adopted under
15 it are violated;

(4) the requiring of detailed, sworn, financial reports of operations from permittees and licensees including detailed statements of receipts and payments;

(5) the investigation of permittees, licensees, registered vendors, and their employees, including the fingerprinting of those permittees, licensees, registered vendors, and employees whom the department considers it advisable to fingerprint;

(6) the method and manner of conducting authorized activities and awarding of prizes or awards, and the equipment that may be used;

(7) the number of activities that may be held, operated, or conducted under a permit during a specified period; however, the department may not allow more than 14 bingo sessions a month and 35 bingo games a session to be conducted under a permit; the holders of a multiple-beneficiary permit under AS 05.15.100(d) may hold, operate, or conduct the number of sessions and games a month equal to the number allowed an individual permittee per month multiplied by the number of holders of the multiple-beneficiary permit;

(8) a method of accounting for receipts and disbursements by operators, including the keeping of records and requirements for the deposit of all receipts in a bank;

(9) the disposition of funds in possession of a permittee, a person, municipality, or qualified organization that possesses an operator's license, or a registered vendor at the time a permit, a license, or a vendor registration is surrendered, revoked, or invalidated;

(10) restrictions on the participation by employees of the Department of Fish and Game in salmon classics, [AND IN] king salmon classics, and big bull moose derbies, and by employees of Douglas Island Pink and Chum in king salmon classics;

(11) other matters the department considers necessary to carry out this chapter or protect the best interest of the public.

* Sec. 2. AS 05.15.100(a) is amended to read:

(a) The department may issue a permit to a municipality or qualified organization. The permit gives the municipality or qualified organization the privilege of conducting bingo, raffles and lotteries, pull-tab games, ice classics, race classics,

1 rain classics, goose classics, mercury classics, deep freeze classics, canned salmon
2 classics, salmon classics, king salmon classics, dog mushers' contests, snow classics,
3 snow machine classics, fish derbies, animal classics, crane classics, cabbage classics,
4 Calcutta pools, big bull moose derbies, and contests of skill.

5 * Sec. 3. AS 05.15.115(c) is amended to read:

6 (c) A permittee may not contract with more than one operator at a time to
7 conduct the same type of activity. For the purposes of this subsection, bingo games,
8 raffles, lotteries, pull-tab games, ice classics, race classics, rain classics, goose
9 classics, mercury classics, deep freeze classics, canned salmon classics, salmon
10 classics, king salmon classics, dog mushers' contests, snow classics, snow machine
11 classics, fish derbies, animal classics, crane classics, cabbage classics, big bull moose
12 derbies, and contests of skill are each a different type of activity.

13 * Sec. 4. AS 05.15.180(b) is amended to read:

14 (b) With the exception of raffles, lotteries, bingo games, pull-tab games, race
15 classics, rain classics, goose classics, mercury classics, deep freeze classics, dog
16 mushers' contests, snow classics, snow machine classics, canned salmon classics,
17 salmon classics, animal classics, crane classics, cabbage classics, Calcutta pools, big
18 bull moose derbies, and king salmon classics, an activity may not be licensed under
19 this chapter unless it existed in the state in substantially the same form and was
20 conducted in substantially the same manner before January 1, 1959. A snow machine
21 classic may not be licensed under this chapter unless it has been in existence for at
22 least five years before the licensing. An animal classic may not be licensed under this
23 chapter unless it was in existence before November 1, 2002.

24 * Sec. 5. AS 05.15.690(26) is amended to read:

25 (26) "ice classic" means a game of chance where a prize of money is
26 awarded for the closest guess of the time the ice moves in a body of water or
27 watercourse in the state and is limited to the Nenana and Chena Ice Pools in the same
28 manner as they were conducted in 1959 and previous years, a Kuskokwim Ice Classic
29 to be operated and administered by Bethel Community Services Foundation, Inc., a
30 Kenai River Ice Classic to be operated and administered by the Kenai and Soldotna
31 Rotary Clubs jointly or by either the Kenai Rotary Club or the Soldotna Rotary Club, a

1 Yukon River Ice Classic to be operated and administered by the City of Fort Yukon,
2 an Alaska-Soviet Ice Classic to be operated and administered jointly by CAMAI, Inc.,
3 and the City of Diomed, a Big Lake Ice Classic to be operated and administered by
4 the Houston Junior-Senior High School Booster Club and the Big Lake Chamber of
5 Commerce jointly or by either the Houston Junior-Senior High School Booster Club
6 or the Big Lake Chamber of Commerce, [AND] a McGrath Ice Classic to be operated
7 and administered by the Kuskokwim Public Broadcasting Company, and the Snow
8 Town Ice Classic to be operated and administered by the Advocates for Victims
9 of Violence, Inc.;

10 * Sec. 6. AS 05.15.690 is amended by adding a new paragraph to read:

11 (50) "big bull moose derby" means a contest in which prizes are
12 awarded for harvesting bull moose based on the size or spread of the antlers.
