### BILL NO. HB 313

## Analysis

This legislation provides for a mitigator at sentencing if, at the time of the offense, the defendant suffered from combatrelated post-traumatic stress disorder or combat-related traumatic brain injury which significantly affected the defendant's behavior. This mitigator only applies to non-violent crimes.

This legislation could impact a number of offenders incarcerated for non-violent crimes. However, at this time, data is not available for the Department to calculate the number of defendants who would be able to take advantage of this mitigator. The Department will continue to monitor the potential impacts of this legislation.
