Analysis

Military Reporting Requirements (Section 3): Adds additional data requirements regarding military data.

AS 14.03.120 (d) (10) The Student Report Manager software system, to gather data reliably, is \$35.0 to modify. Handbook modifications and initial year district technical assistance on new reporting requirement is estimated at \$45.0. Technical assistance for districts with military personnel to establish reliable data gathering methods around these elements for three subsequent years is \$10.0 each year.

HSGQE (Section 38): AS 14.03.075 and AS 14.07.165(5) are repealed. Repeals the High School Graduation Qualifying Exam (HSGQE), effective September 1, 2014.

Charter School Governance [Section 6 (F)]: Costs associated with this section are indeterminate and not included in the numbers on the front page of the fiscal note as it is unknown how many current charter schools or new charter schools may fall into this option if the local district does not renew or approve an application. As districts provide centralized services to support charter schools at different levels depending on the size of the charter, DEED is offering what types of costs may be associated with running a school district. These costs may include a division director (Range 27A, \$140.0); an Educational Administrator (Range 22 A, \$120.0) to provide oversight of the school(s); two Education Specialists to oversee instructional and special education programs (two range 21 A, at 105.0 each, 210.0); one School Finance Officer II for financial oversight (100.0); one admin assistant for clerical support (75.0); and Administrative Service position charge back for 5 positions (42.5). Additional costs would include centralized services to incorporate charter school staff into the state employment pool. Those costs too would depend on the number of charter schools that would fall under this provision.

TVEP (Section 17): AS 23.15.835(d) is amended.

The legislation continues the Alaska technical and vocational education program (TVEP) through June 30, 2018. The Technical and Vocational Education Fund authorized under AS 23.15.840 sunsets on June 30, 2014.

Out-year cost estimates are based on TVEP receipts included in the Department of Education & Early Development's (DEED) FY2015 budget request and will be revised annually based on the balance of the fund.

This funding is a grant from DEED to the Galena Project Education Vocational Training Center, currently \$434.5.
