FISCAL NOTE ANALYSIS

STATE OF ALASKA 2014 LEGISLATIVE SESSION

BILL NO. SB 132

Analysis

This bill amends the requirement under AS 28.10.411(f), that a person must be 65 years of age or older by January 1 of the year the vehicle registration is due to be entitled to an exemption from registration fees.
Revenue loss: DMV vehicle records do not contain a field for date of birth. Therefore, DMV is unable to determine how many vehicles are owned by persons who will be 65 years or older this year or in future years.
In the absence of reliable information, a zero fiscal note is submitted.
