# BILL NO. HB 362

## Analysis

HB362 adds a new chapter to AS 17 criminalizing the display, advertising or sale or substances defined by the chapter as "illicit synthetic substances." The definition of what constitutes an illicit synthetic drug includes very broad descriptive terms which might raise constitutional questions or challenges in an actual case.

The Agency cannot accurately predict the fiscal impact of this legislation. Therefore the agency submits an indeterminate fiscal note.
