8 **Sec. 38.05.023. Legislative approval of agreements and contracts**
9 **associated with a North Slope natural gas project; effect of failing to approve. (a)**

10 The commissioner shall deliver proposed agreements and contracts associated with a
11 North Slope natural gas project negotiated under the authority of AS 38.05.020(b)(11)
12 along with supporting documentation to the presiding officer of each house of the
13 legislature for action as provided in this section and provide a copy of each proposed
14 agreement or contract to each member of the legislature, regardless of whether the
15 legislature is in session. If the commissioner proposes more than one agreement or
16 contract for legislative approval, the commissioner shall

17 (1) combine agreements and contracts for delivery so that the
18 legislature does not consider agreements or contracts negotiated under
19 AS 38.05.020(b)(11) more than twice in a calendar year; and

20 (2) provide an explanation as to the effect of the legislature's approving
21 or failing to approve each agreement or contract as that agreement or contract relates
22 to all agreements and contracts presented for approval.

23 (b) After the presiding officer of each house of the legislature receives

1 proposed agreements and contracts from the commissioner under (a) of this section,
 2 the rules committee of each house of the legislature shall introduce a bill in the
 3 committee's respective chamber that provides for the approval of the proposed
 4 agreements and contracts.

5 (c) If a bill approving one or more of the proposed agreements or contracts
 6 passes the legislature within 90 days after the last date a presiding officer receives one
 7 or more proposed agreements or contracts from the commissioner under (a) of this
 8 section, the commissioner may execute each agreement or contract approved by the
 9 legislature.

10 (d) Notwithstanding a legislative rule that prohibits the carryover of a bill after
 11 the end of a special session or after the end of a regular session of a legislature, a bill
 12 introduced under (b) of this section that is not passed or not withdrawn, defeated,
 13 vetoed, or indefinitely postponed shall be carried over to any subsequent regular or
 14 special legislative session convened during the 90-day period described in (c) of this
 15 section in the same reading or status it was in at the time of adjournment. However, a
 16 bill introduced under (b) of this section may not be carried over to the first regular
 17 session of a legislature.

18 (e) If the legislature fails to approve a proposed agreement or contract, the
 19 commissioner

20 (1) may not execute the agreement or contract the legislature fails to
 21 approve;

22 (2) may not resubmit to the legislature an agreement or contract that
 23 the legislature fails to approve; and

24 (3) may renegotiate a new agreement or contract under
 25 AS 38.05.020(b)(11) and submit the new agreement or contract for approval under (a)
 26 of this section."
