Dear Senator Micciche:

During your consideration of Senate Bill 209 I encourage you to ensure that e-cigarettes are included as devices that must comply with all other smoking or non smoking requirements in the State of Alaska.

Smoke-free air for all Alaskans is important to me. Nobody should have to choose between their health and their job. If people want to smoke tobacco or use e-cigarettes, they're free to do so. They just need to take it outside.

Ultra-fine particles and volatile organic compounds have been found in the secondhand aerosol of e-cigarettes. Both of these pollutants are risks for lung cancer, the #1 cancer killer. In addition, the FDA found heavy metals and other carcinogens, along with nicotine in the emissions of electronic cigarette products.

As a cancer survivor who had complications at Alaska hospitals and sub sequentially spent time at the Mayo clinic, I received quite the education in what causes cancer. Doctors and surgeons at the Mayo clinic use the number of 80% of which cancer is caused by smoking. I heard the number over and over. I have not smoked since 1981 but was assured that smoking probably caused my cancer. Since then I and my wife, who is also a cancer survivor, are very cognizant of places where smoking is allowed, even in an outside area, and avoid those areas. We feel that all parks should be added to the list of places where smoking is not allowed.

Please keep HB360 and SB209 moving through committee so Alaskans can breathe easier starting this year and Alaska can become the 31<sup>st</sup> state to protect its citizens with a statewide law. Thank you for your support.




