2. Can you tell us who the 5 districts are that did not provide CBA expiration dates?

We previously indicated that five districts did not provide CBA expiration dates. Additionally, Nome and Saint Mary's indicated they provide health plan coverage to collectively bargained groups, which suggests that these school districts have CBAs, but we did not receive CBA expiration date for these districts.

3. Can you tell us if we still see savings if one of the big five school districts joins the AlaskaCare cost sharing structure?

Based on one of the largest five school districts enrolling in AlaskaCare with the smaller 48 districts, the aggregate potential cost savings will increase. In general, the additional per-capita savings from adding a larger district is not as great as adding a smaller district because smaller districts usually have more administrative overhead (stop loss fees, brokerage revenue, fully insured overhead, etc.). However, the procurement of health care vendors benefits from having a larger group to negotiate the best possible deal for a state managed program for district employees.

a. What about if all five join? Does that hurt the Alaska Care cost sharing structure?

We would like to gather more information about this question in order to provide the best answer.
