FOR AN ACT ENTITLED

1 **"An Act relating to the exemption from jury service for certain teachers; relating to the**
2 **powers of the Department of Education and Early Development; relating to school**
3 **performance reports; relating to accountability standards; providing funding for**
4 **Internet services; relating to secondary school course credit earned through assessment;**
5 **relating to public school college and career readiness assessments and diplomas; relating**
6 **to the secondary school competency examination and related requirements; relating to**
7 **charter schools and student transportation; relating to residential school applications;**
8 **relating to school construction bond debt reimbursement; increasing the stipend for**
9 **boarding school students; relating to the local contribution to public school funding;**
10 **increasing the base student allocation used in the formula for state funding of public**
11 **education; relating to correspondence programs, funding, and student allotments;**
12 **relating to funding of and reporting by Alaska technical and vocational education**

1 **programs; relating to earning high school credit for completion of vocational education**
2 **courses offered by institutions receiving technical and vocational education program**
3 **funding; relating to schools operated by a federal agency; relating to education tax**
4 **credits; establishing an optional municipal tax exemption for privately owned real**
5 **property rented or leased for use as a charter school; establishing a pilot project for**
6 **public middle school students; requiring the Department of Administration to provide a**
7 **proposal for a salary and benefits schedule for school districts and for teacher tenure;**
8 **requiring the Legislative Budget and Audit Committee to provide for studies on the**
9 **school size factor and the school district cost factor for public education funding;**
10 **requiring the Department of Education and Early Development to report to the**
11 **legislature on school design and construction; relating to grants to school districts; and**
12 **providing for an effective date."**

13 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

14 * **Section 1.** AS 09.20.030(b) is amended to read:

15 (b) A person may claim exemption and shall be excused by the court from
16 service as a juror during the school term if it is shown that the person is a teacher in a
17 school that is designated as **a low performing school under regulations adopted by**
18 **the state Board of Education and Early Development** [FAILING TO MAKE
19 ADEQUATE YEARLY PROGRESS UNDER P.L. 107-110]. In this subsection,
20 "teacher" means a person who serves a school district in a teaching capacity in a
21 classroom setting and is required to be certificated in order to hold the position.

22 * **Sec. 2.** AS 14.03 is amended by adding a new section to read:

23 **Sec. 14.03.073. Secondary school course credit.** (a) A school district shall
24 provide the opportunity for students enrolled in a secondary school in the district to
25 challenge a course provided by the district by demonstrating mastery in mathematics,
26 language arts, science, social studies, and world languages at the level of the course
27 challenged. A school district shall give full credit for a course to a student who

1 successfully challenges that course as provided under this section.

2 (b) A school district shall establish, within a reasonable time, an assessment
3 tool and a standard for demonstrating mastery in secondary school courses provided
4 by the district under this section.

5 (c) The board shall adopt regulations to implement this section.

6 (d) In this section, "school district" has the meaning given in AS 14.30.350.

7 * **Sec. 3.** AS 14.03.075 is repealed and reenacted to read:

8 **Sec. 14.03.075. College and career readiness assessment.** (a) A school may
9 not issue a secondary school diploma to a student unless the student takes a college
10 and career readiness assessment or receives a waiver from the governing body.

11 (b) A school shall award a certificate of achievement to a student who fails to
12 qualify for a diploma under (a) of this section by the end of the student's final semester
13 of attendance but who has met all other graduation requirements of the governing
14 body and the state.

15 (c) The department shall provide funding for the fee for a single
16 administration of a college and career readiness assessment for each secondary student
17 within two years of the student's expected graduation.

18 (d) In this section, "college and career readiness assessment" means the SAT,
19 ACT, or WorkKeys assessment.

30 (3)] progress of the department

31 (A) toward implementing the school accountability provisions

1 of AS 14.03.123; and

2 (B) in assisting high schools to become accredited;

3 (3) [(4)] a description of the resources provided to each school and
4 school district for coordinated school improvement activities and staff training in each
5 school and school district;

6 (4) [(5)] each school district's and each school's progress in aligning
7 curriculum with state education performance standards;

8 (5) [(6)] a description of the efforts by the department to assist a public
9 school or district that receives a low performance designation under AS 14.03.123
10 [OF DEFICIENT OR IN CRISIS];

11 (6) [(7)] a description of intervention efforts by each school district
12 and school for students who are not meeting state performance standards; and

13 (7) [(8)] the number and percentage of turnover in certificated
14 personnel and superintendents [;

20 (d) The department and the state Board of Education and Early Development
21 may not enter into or renew a contract or agreement, or participate, with any
22 organization, entity, group, or consortium after the effective date of this section that
23 requires the state to cede any measure of autonomy or control over education
24 standards and assessments, including the determination of passing scores.

25 * **Sec. 6.** AS 14.03.120(d) is amended to read:

26 (d) Annually, before the date set by the district under (e) of this section, each
27 public school shall deliver to the department for posting on the department's Internet
28 website and provide, in a public meeting of parents, students, and community
29 members, a report on the school's performance and the performance of the school's
30 students. The report shall be prepared on a form prescribed by the department and
31 must include

8 (f) In the accountability system for schools and districts required by this
9 section, the department shall

10 (1) implement 20 U.S.C. 6301 - 7941 (Elementary and Secondary
11 Education Act of 1965), as amended;

12 (2) implement state criteria and priorities for accountability including
13 the use of

14 (A) measures of student performance on standards-based
15 assessments in **language arts** [READING, WRITING,] and mathematics [,
16 AND INCLUDING COMPETENCY TESTS REQUIRED UNDER

18 (B) measures of student improvement; and

19 (C) other measures identified that are indicators of student
20 success and achievement; and

27 that is equal to the amount needed to bring the applicant's share to 10 megabits of
28 download a second of the Internet services.

29 (b) If insufficient funding is appropriated to provide funding authorized under
30 this section, the state share shall be distributed pro rata to eligible school districts.

1 (1) "applicant's share" means the difference between the cost of
2 Internet services that are eligible for the discount under the federal universal services

9 prescribe an application procedure for the establishment of a charter school in that
10 school district. The application procedure must include provisions for an academic
11 policy committee consisting of parents of students attending the school, teachers, and
12 school employees and a proposed form for a contract between a charter school and the
13 local school board, setting out the contract elements required under AS 14.03.255(c).

14 (b) A decision of a local school board approving or denying an application for
15 a charter school must be in writing, must be issued within 60 days after the
16 application, and must include all relevant findings of fact and conclusions of law.

17 (c) If a local school board approves an application for a charter school, the
18 local school board shall forward the application to the state Board of Education and
19 Early Development for review and approval.

20 (d) If a local school board denies an application for a charter school, the
21 applicant may appeal the denial to the commissioner. The appeal to the commissioner
22 shall be filed not later than 60 days after the local school board issues its written
23 decision of denial. The commissioner shall review the local school board's decision to
24 determine whether the findings of fact are supported by substantial evidence and
25 whether the decision is contrary to law. A decision of the commissioner upholding the
26 denial by the local school board may be appealed within 30 days to the state Board of
27 Education and Early Development.

29 commissioner shall forward the application to the state Board of Education and Early
30 Development for review and approval. The application shall be forwarded not later
31 than 30 days after the commissioner issues a written decision. The state Board of

1 Education and Early Development shall exercise independent judgment in evaluating

3 (f) A local school board that denied an application for a charter school
4 approved by the state board on appeal shall operate the charter school as provided in
5 AS 14.03.255 - 14.03.290.

7 **Sec. 14.03.253. Charter school application appeal.** (a) In an appeal to the
8 commissioner under AS 14.03.250, the commissioner shall review the record before
9 the local school board. The commissioner may request written supplementation of the
10 record from the applicant or the local school board. The commissioner may

11 (1) remand the appeal to the local school board for further review;

12 (2) approve the charter school application and forward the application
13 to the state Board of Education and Early Development with or without added
14 conditions; or

15 (3) uphold the decision denying the charter school application; if the
16 commissioner upholds a local school board's decision to deny a charter school
17 application and the applicant appeals to the State Board of Education and Early

29 principal of the charter school shall be selected by the academic policy committee and
30 shall select, appoint, or otherwise supervise employees of the charter school; and (3)
31 operates under the charter school's annual program budget as set out in the contract

2 school board may exempt a charter school from other local school district
3 requirements if the exemption is set out in the contract. A charter school is subject to

11 meets requirements for health and safety applicable to public buildings or other public

21 **department up to four percent. Costs directly related to charter school facilities,**
22 **including rent, utilities, and maintenance, may not be included in an annual**

 9 established on or after the effective date of this section may receive a one-time grant

 12 charter school shall use a grant received under this section to provide educational

 27 shall annually provide an individual learning plan for each student enrolled in the
 28 program developed in collaboration with the student, the parent or guardian of the
 29 student, a certificated teacher assigned to the student, and other individuals involved in
 30 the student's learning plan. An individual learning plan must

31 (1) be developed with the assistance and approval of the certificated

1 teacher assigned to the student by the district;

2 (2) provide for a course of study for the appropriate grade level
3 consistent with state and district standards;

4 (3) provide for an ongoing assessment plan that includes statewide

14 additional requirements, other than the requirements specified under (a) of this section
15 and under AS 14.03.320, on a student who is proficient or advanced on statewide
16 assessments required under AS 14.03.123(f).

18 section, the department or a district that provides a correspondence study program may
19 provide an annual student allotment to a parent or guardian of a student enrolled in the

23 from a public, private, or religious organization with a student allotment provided

27 (2) textbooks, services, and other curriculum materials and the course
28 of study

29 (A) are approved by the school district;

30 (B) are appropriate for the student;

31 (C) are aligned to state standards; and

1 (D) comply with AS 14.03.090 and AS 14.18.060; and

2 (3) otherwise support a public purpose.

3 (c) Except as provided in (d) of this section, an annual student allotment
4 provided under this section is reserved and excluded from the unreserved portion of a
5 district's year-end fund balance in the school operating fund under AS 14.17.505.

6 (d) The department or a district that provides for an annual student allotment
7 under (a) of this section shall

8 (1) account for the balance of an unexpended annual student allotment
9 during the period in which a student continues to be enrolled in the correspondence
10 program for which the annual allotment was provided;

11 (2) return the unexpended balance of a student allotment to the budget
12 of the department or district for a student who is no longer enrolled in the
13 correspondence program for which the allotment was provided;

14 (3) maintain a record of expenditures and allotments; and

15 (4) implement a routine monitoring of audits and expenditures.

16 (e) A student allotment provided under (a) of this section may not be used to
17 pay for services provided to a student by a family member. In this subsection, "family
18 member" means the student's spouse, guardian, parent, stepparent, sibling, stepsibling,
