## **Analysis**

HB 113 amends AS 18.70.330(b) to add one seat to the Alaska Fire Standards Council (AFSC) and designate one existing firefighter seat to the Alaska Professional Firefighters Association (AKPFFA).
Designating an existing firefighter seat to the AKPFFA will provide representation at AFSC meetings and will have no fiscal impact.
The addition of one AFSC seat to include the Alaska Fire Chiefs Association (AFCA) will provide designated representation for the AFCA at the AFSC meetings. The addition of this seat will increase travel costs related to AFSC meeting attendance.
Cost for attendance per AFSC member includes airfare, hotel, ground transportation, and per diem. The current average cost for each members' attendance is \$1,150 per meeting, with two meetings occuring per year. Future estimates for travel are based on travel cost increases from the past three years.
