Whereas; the ARDOR's represent a diverse network of public, private and economic development groups that drive local initiatives and advance economic diversification through partnerships with state and local governments; and



Whereas; the APED now comes in support of the following legislation being considered by the Alaska State Legislature:



Dear House Labor and Commerce Committee Members:

I was born and raised in Fairbanks. In 1956 my family moved into our new home on the Chena River. It was heated with coal, a heat source that worked well for a small community in the 1950's. In 1967 our home was flooded. As part of the repairs my parents replaced the coal heat with electric heat. Golden Valley Electric Association had recently completed the Healy Intertie, had cheap power and was encouraging the use of electric heat. Just a few years later the cost of electricity rose substantially and my parents moved to oil heat. Jump ahead 40 years and I am heating my own home with oil, 2,000 gallons per year. Over the past few years, the price of oil has ballooned to \$4/gallon. It costs me approximately \$667 per month to heat my home. It is once again time to change heating sources. Fairbanksans cannot afford to continue heating their homes with oil nor can we afford the degraded air quality that wood and coal heat bring.

I encourage you to support House Bill 74, the Liquid Natural Gas Production and Distribution System funding bill. Fairbanks cannot afford the \$225,000,000 per year drain on its economy brought by oil heat nor the diminished air quality brought by wood heat.

As a Fairbanks business owner for over 40 years we are deeply concerned with the continuously rising cost of energy in our area. Heating oil alone has gone from \$1.33 per gallon to almost \$4.00 per gallon since we built our new building in 2000. An increase of about 200%. Without some kind of energy cost relief we cannot continue to compete with outside businesses or even businesses in Anchorage who enjoy considerable lower energy costs because of the availability of natural gas. As one drives around this community and sees more and more unoccupied commercial buildings one can only be concerned about the economic health of Fairbanks and the towns and villages that it supports. Local businesses cannot afford to pay their employees enough to keep up with these rising costs. Our business has not filled 3 employee vacancies as we struggle to keep the fuel tank filled and the electricity bill paid as well as all other rising costs directly related to energy. Jobs are being lost. Families are moving away because they can no longer afford to live here.

This area has suffered long enough with this problem. Trucking natural gas to the interior of Alaska is the quickest solution to provide all interior communities with affordable energy.

Dear Representative Olson, Speaker Chenault and other honored Representatives:

My name is Diane Hutchison. I am a local Certified Public Accountant in Fairbanks and am also currently serving my second term as the Presiding Officer of the Fairbanks North Star Borough Assembly. We have two major issues in the Fairbanks area that affect the economy of the entire State, not just our area.

1. High energy costs
2. Air quality - PM 2.5 pollution and non attainment of Federal standards.

No area of the State is independent of other areas of the State, whether it is Fairbanks, Anchorage, communities on the North Slope, in Southeast, or the communities that are tied to the vast Yukon River system. If one area of the State does not survive there will be direct fallout to other areas. HB74 will help the entire State, not just our area. Propane could be distributed along our river systems and highways to help lower energy costs to all small communities. A distribution system that is built and set in motion by the passage of HB74 will make areas ready to hook up when a gas pipeline is actually built.

If the EPA determines that Fairbanks air quality is not meeting the goals they have established, the effect on Federal funding for the entire State could be impacted. This would be an unnecessary travesty if we can get enough residences

to convert from wood burning to natural gas. This is good for business, it is even better for our public health. I was born and raised in Alaska and it sickens me to look over our Borough from the surrounding hills and see the brown haze of smoke cloaking the low lying areas.

These two issues affect every industry and economic engine in the Fairbanks North Star Borough - from how the University will heat its campus when a new power plant must be built, to why will students want to come to a polluted area for school, how can the Flint Hills Refinery survive if it can not obtain cheaper energy to use to make its product (which in turn affects the Alaska Railroad and jobs along the railbelt, the Ports of Anchorage, Seward, etc.), the mines that surround the Interior and could possibly be built in outlying areas of the State if gas or propane were available for cheaper electrical and heat, the military - how can more personnel be moved to an area that is already suffering from air pollution, tourism - winter tourism can not be helped by badly polluted air, small businesses - the fact is, they just can't survive many more years of extremely high energy costs, which in turn will affect the other Interior communities they serve and suppliers and shippers in other parts of the great State.

From my Golden Valley electric bill yesterday:

Fuel & Purchased power @.11078, Utility charge @.09597, Regulatory Cost @.000568 -

AS you can see, well over \$.20 per Kwh.

I have many businesses for clients and high energy costs are choking their businesses, they are choking their customers disposable income and we are all choking on dirty, polluted air in the winter temperatures, which as most of you know, is the bulk of our year.

Any help and support you can offer for passage of HB74 will be sincerely appreciated. From a fellow Alaskan and someone who appreciates all of the tireless effort you put into each issue that comes before you.

I am the Project Director for Polar LNG, LLC, one of the entities that responded to AIDEA's request for letters of interest in the Governor's proposed plan for financing a project to deliver energy cost relief to Interior Alaska. I am also a resident of Fairbanks, and would be highly supportive of this project, even if I were not directly involved.

This bill is worthy of funding because it accomplishes several goals which benefit Interior Alaska and the State at large.

- 1) It will deliver natural gas and propane at half the present cost of oil. The costs are not directly indexed to oil, providing a low risk that oil would become a less costly alternative during the life of natural gas project.
- 2) Natural gas is a cleaner burning fuel, and will help alleviate the air quality issues in Fairbanks and North Pole.
- 3) Due to the energy cost savings, approximately \$200 million will be available to circulate throughout the economy.
- 4) The concept of trucking LNG is well proven, and is currently in use in Alaska and in many areas of the lower 48.
- 5) This project is the fastest path to providing clean burning, lower priced natural gas, and can provide a bridge solution until a pipeline is developed.
- 6) The combination of direct investment and low cost loans offers the State a return on capital, and provides interior Alaska residents much needed energy cost relief.

I am writing today in support of SB 23 in response to the remark that there did not appear to be much public support for the proposal.

I would much rather have a pipeline but since that seems to be beyond the capabilities of any official entity. Since the private companies do not seem to be interested either, I have a feeling that day will be never. A pipeline has been discussed for years and nothing has progressed much at this time.

Given the fact that fuel bills in Fairbanks are double Anchorage and the other Southeast communities costs for heating, I feel this would be the best alternative at this time to providing a reasonable fuel cost for the Interior residents. Some of the older homes in Fairbanks have run fuel costs of \$1300 for 30-45 days of use. Many of the people inhabiting those homes are unable to afford retrofitting for more energy efficiency and often do not qualify for the other weatherization programs. Several acquaintances have already left the state due to the cost of living here and more specifically, the cost of heat and electricity. Speaking with other friends, almost all have had at least one neighbor or friend leave before the cost of heat and lights buried them in debt so deep they could not get out.

That is one thing that not a lot of the public letters have mentioned in the past. I do not have the exact figures although they were, I believe, published some time ago in the newspaper. Electric costs for SE and Anchorage are also much lower than Fairbanks due to the fuel surcharge imposed by GVEA in an effort to continue making money/breaking even.

Between heating costs and electricity, my husband and i have been seriously wondering if we are going to be able to retire here as we have always planned. We have lived in Anchorage for about five years , then a brief time Outside and back to Fairbanks for the past 33 years. Our mortgage is almost paid in full and will be by the time we are ready to retire. But even with our careful planning and investments, staying in Fairbanks will be touch and go as costs will continue to rise for fuel oil and electricity (due to fuel oil costs). With an affordable heating solution, staying where we are is a much more viable option.

I find it hard to explain to friends and family in the lower 48 just why our fuel bills and gas costs are so much higher than their costs. Given the fact that we are considered an energy-rich state, it makes it even harder to explain.

Please consider these items when discussing the outcome of SB 23. I know Fairbanks is smaller and often considered not as important as other areas, but we are part of Alaska and are very important to a number of the rural communities as well.

I have lived in interior Alaska for many years as my parents and grandparents. I enjoy Alaska and the many wonderful opportunities the State has to offer; wonderful people, a unique country that we all can cherish. We all would like to leave an Alaska to our children where they can have the same opportunities to raise their families and enjoy Alaska as many of us have.

One of the greatest challenges to raising a family in interior Alaska is the cost of energy and space heat. Although Alaska has many resources available we have not made these resources available for many of its citizens. The bill can benefit many smaller communities with the gas storage credits previously passed. Both North Pole and Fairbanks communities continue to struggle with poor air quality issues caused by burning alternative fuels. The health issues are real and have significant consequences to many of interior citizens.

Hi. My name is Lynn Grover. I live in the Rectangle of Death in North Pole, Alaska. It is aptly named as it frequently has the worst air quality not only in the Fairbanks North Star Borough, the state, and the United States, all, but also in the world. We beat China many days. While the air in North Pole is frequently the worst, it is a borough-wide problem with some areas worse than others.

For the above reason, in addition to the affordability of natural gas, we need natural gas in the Fairbanks North Star Borough.

The poor air quality has been going at the current level for about 4 years. Local and state politicians have done little to nothing to help. While they sit on their hands, a few hundred people are allowed to make tens of thousands sick/unhealthy. Those few hundred are also allowed to greatly diminish the quality of life of tens of thousands of people who can no longer walk in their neighborhoods or go out in their own yards to play with their children, or else they will have some serious health effects. To make matter worse, there is no escape for some of us, not even inside our homes: The smoke even gets in our homes, seriously impacting health, as well. We need natural gas in order to stop the 24/7 burning of wood/coal/whatever that is literally making us sick with the some of the worst air quality in the world.

And why are the few hundred people allowed to this? It's all in the name of staying warm as cheaply as possible, regardless of how it impacts everybody (whether they realize it or not, even the people doing this are impacting their own health). About 4 years ago, the price of heating oil skyrocketed. Instead of spending thousands of dollars to upgrade their homes' energy efficiency and budget more wisely, some people decided to spends thousands of dollars to install outdoor wood and coal boilers, which are extremely polluting, to say the least. Additionally, people began using wood and coal stoves. There are many people who using these devices improperly. There are also many people who are burning wet wood, trash, etc. We need natural gas. This can help our pocketbooks immensely.

This situation should have never been allowed in the first place—natural gas is long overdue to us. In an area well already well known for its inversion and air quality problems, the use of outdoor boilers and stoves that burn 24/7 should have never been allowed. Natural gas should have been afforded us a long time ago. It has been talked about for decades. It is time for natural gas.

I have lived in Fairbanks my entire life and cannot imagine living anywhere else but with the rising costs of energy i.e. fuel and electricity I may soon not have a choice. Fairbanks needs an option besides heating with fuel oil it is beginning to cripple our economic growth and population base. I spend almost \$5200.00 a year in fuel oil alone to heat my home. Someone outside of Fairbanks has no idea what it is like to come home and find a fuel oil delivery ticket hanging on your door. The anxiety of what will the fuel price be, will the bill be under \$2500.00, what am I not going to pay this month so that I can pay this bill, it is awful, I have no idea how people who make less than my family make it through the winter. We pay almost \$3000 in electric bills a year and we are not the most frivolous people in the world either. That is almost \$10,000 a year to heat, light and run my appliances in my home.

Dear Sir,

I sent you an e-mail yesterday and would like to add this to my comments regarding HB74.

A friend of mine has a 1952sf ranch house in Kenai/Soldotna, I have a 2016sf two story (considered a more efficient heating design than a ranch) in Fairbanks. His natural gas heating cost is roughly \$1080 per year, my heating cost is roughly \$5040 per year in heating oil or about 5 times what it costs to heat a house on the Kenai Peninsula serviced with natural gas. Additionally, I am supplementing my oil heat with a wood stove, he uses only natural gas.

To heat our 13,000sf store with heating oil cost nearly \$70,000 annually 3 years ago, even after investing a little over \$40,000 in better roofing insulation. To offset the utility costs, our entire staff of 34 employees (at that time) had to take a 10% paycut and loss of some benefits in order for us to survive. If changes are not on the horizon I foresee probable layoffs in our future.

Action, not debate, needs to be taken to provide an energy cost solution for interior Alaska before we experience economic failures due to utility costs on a much larger scale than we have seen already.

Dear Mr. Chairman:

NovaCopper is a company engaged in advanced exploration work in the Ambler Mining District, in partnership with NANA on the Upper Kobuk Mineral Project. Energy is one of the largest costs of constructing and operating a mining project in remote parts of Alaska. We are aware of the work that AEA is undertaking to pursue LNG trucking as an energy option for Interior Alaska, and the pending legislation (SB 23/HB 74).

Although we have not yet defined a project, the scale of operation we are anticipating would require construction of a 20 to 30 MW power plant which, if powered by gas, would require approximately 2 to 3 bcf per year. NovaCopper is aware that there are other potential mine sites in the district operated by other companies that could augment the power requirements for the district.

As we look at energy options for our project, the LNG trucking option is something that could be attractive, provided it is cost-effective. Based on the AEA presentation reviewing the LNG trucking option given in Fairbanks on February 27, 2013, the delivered cost for gas (including regasification and storage) is expected to be half of that for fuel oil. Obviously, if these estimates are accurate, trucking LNG to the Ambler Mining District (approximately the same distance from the North Slope as Fairbanks) could provide a competitive and clean source of energy to operate potential mines in the district as well as provide power for local village needs. The option for LNG only works for us, of course, if the Road to the Ambler District Resources, currently being studied by ADOT and potentially financed by AIDEA, is constructed. For this reason, we encourage the State to continue advancing its work on the Road to the Ambler District and in evaluating the LNG trucking potential for Interior Alaska residents, and other potential energy users, including industrial users.

If I can be of any assistance in this matter, please do not hesitate to contact me. I would be happy to assist in any way possible to bring affordable, clean energy alternatives to the Ambler Mining District.

**Re: House Operating Budget**

Dear Honorable Representatives:

I was not able to testify today at the House hearings on the operating budget. Mayor Hopkins spoke on behalf of the three mayors regarding our thoughts, however, I would like to reiterate our support for the Governor's recommended amendment to appropriate \$125 million from receipts of the Alaska Housing Capital Corporation created under AS 18.56.086 to the Alaska Industrial Development and Export Authority sustainable energy transmission and supply development fund. This was in the FY2014 Governor's budget, but the actual language was inadvertently omitted from the operating bill.

For the first time in years, we have hope that energy legislation will be enacted. The LNG trucking plan, combined with HB4 and HB35, give a complete package in finally addressing extremely serious energy needs for Alaska. Even though the LNG trucking plan is designed to help Interior Alaska, which is reeling from high energy costs, it also serves as insurance for South Central Alaska in case gas supplies from the Kenai are not sufficient. HB4 and HB35 take a broad look at energy needs for all Alaska and will bring to us long term solutions and add to the basic infrastructure needs of our state that have long been talked about.

I would like to offer support from Copper Valley Development Association, the regional ARDOR with Department of Commerce, Community and Economic Development for Senate Bill 23 and House Bill 74. This bill that authorizes the Alaska Industrial Development and Export Authority (AIDEA) to provide financing for a natural gas liquefaction plant and affiliated infrastructure on the North Slope and a natural gas distribution system and affiliated infrastructure within the Fairbanks North Star Borough. These facilities will make it feasible to truck liquefied natural gas from the North Slope to the Interior, and will allow for a wider distribution of gas and propane elsewhere in the state. SUPPORT HB 74/SB 23 – LNG production and distribution system

Dear Representative Olson:

We are writing to support House Bill 74 - relating to development and financing of a liquefied natural gas production and distribution system from the North Slope. We respectfully ask for your expeditious and favorable consideration as you deliberate this Legislation in your Committee.

Fairbanks businesses and residents are struggling with high energy costs and we believe that HB 74 is a rational short term solution. LNG Trucking from the north-slope aligns with the broader effort to bring a pipeline from the north slope of Alaska in that it will allow for the gas market to mature in Fairbanks.

Tower Hill Mines, Inc. (NYSE: THM) is currently conducting a feasibility study on the Livengood Gold Project located 70 miles north of Fairbanks adjacent to the Dalton Highway in the Tolovana Mining District.

Tower Hill, like the rest of Alaska, is looking for a more cost effective energy source. Energy costs comprise a large part of mine operating expenses – perhaps 20 to 30% - and can heavily influence the economics of projects. Energy for electric generation, space heating, and transportation fuels are among the opportunities associated with LNG Trucking and a gas pipeline that we see.

Ultimately, a gas pipeline will provide a more cost effective source of energy, but the interior cannot wait. However, the lower energy cost from LNG trucking into the interior offers substantial savings even if only for a 5-8 year period before a pipeline comes into Fairbanks.

We thank you for your leadership on this critical issue facing the interior of Alaska.

Dear Representative Kurt Olson,

Fairbanks residents, businesses, local government and our state representatives support the development of natural gas resources and their cost-effective distribution to the Fairbanks community. The Fairbanks News-Miner reports comments from you as Chair of the House Labor and Commerce Committee that you think there may not be such support and that you may prevent consideration of a supporting bill by the full House that would address that problem by gas trucking. I am dismayed by the comments attributed to you and upset that an important step in maintaining the viability of Fairbanks may be derailed by an opinion so at odds with the facts I see "on the ground" in Fairbanks. And I believe thousands of other Interior residents are as well.

I cannot count the number of local meetings I have attended at which natural gas availability in the Interior, as one component of a wider effort to provide affordable energy to the interior, has been touted as the number one issue facing Fairbanks - literally a "do or die" issue for this community. Does the trucking plan answer our prayers for affordable energy and assure the future of Fairbanks? Of course not. No one thing will solve the problem of high energy costs in the Interior. But it is a part of the answer.

We - the Alaskan Interior, Fairbanks, the Alaska Legislature, and the state of Alaska itself - appear to be in the grips of the fallacy of the perfect being the enemy of the good. Many proposals for energy development and distribution have been on the table, but proponents of each one seem to target all the others - especially the ones that could help in the near future - as less than perfect. The net result has been inaction and deepening of the crisis of unaffordable energy in Fairbanks. If continued, this will strangle us.

I urge you to support this current partial and temporary contribution to stabilizing energy costs in Fairbanks. More important, I urge to support other good ideas as well. I believe the future of the Interior and the future of Alaska depend upon it.
