Subject: Trucking Gas to Fairbanks

Rep. Olson, my husband and I were unable to attend the committee hearing on trucking gas to the Interior, but we feel it's important to weigh in on the bill nevertheless.

We are within 6 or 7 years of retirement – both from state government service (he a teacher and school administrator, me as an administrator). We have lived in Fairbanks for most of our twenty years here, and we would like to retire here. But as we began to compare the costs of living in Fairbanks after retirement to that of other Alaska communities, we were shocked. We are concerned that it will not be possible to stay in the Interior unless something dramatic happens soon to bring down the cost of utilities.

I have two examples for you that quantify our concerns:

- 1. We recently added up our heating oil and electricity costs for the last year in our Fairbanks home. For a 2500 sq. ft., 4-star-plus home, we paid an average of \$600/month for heating oil and \$230/month for electricity and that's with **no fuel purchased at all** between May 1 and September 1. **An average of \$830 a month!**
- 2. In projecting our after-retirement costs for a home of the same size in Fairbanks and Sterling, we were shocked to find that between utilities and property taxes, we would have at least \$1,000 a month more disposable income in Sterling. (Sterling offers a \$300,000 property tax exemption for seniors instead of the \$150,000 in Fairbanks, and Sterling's fuel source is natural gas.) A \$12,000 a year difference is hard to ignore.

Please do everything you can to bring gas (and other lower cost fuel technology) to Fairbanks as soon as possible.
