Re: Testimony on CSHB 77 (RES)

Mr. Chairman and Members of the Committee:

I am the Executive Director of the Bristol Bay Heritage Land Trust. Over the last five years we have raised over \$1 Million Dollars to help fund instream flow reservations for fish. The irony for us is much of our effort is targeted for retroactive cancellation by the very State that encouraged us to do this work in the first place.



We ask that you don't rush to approve HB 77. Pause and make an effort to really understand Alaska water law. If you do I'm sure you will see how the State benefits from private instream flow reservations. We are always quick to support privatization of public services where it can be done cost effectively and without compromising the public interest. Our work is a perfect example of a public-private partnership. Fish & Game has the responsibility to protect fish – a difficult job in a vast state. Fish & Game does file most instream flow reservations, but can't be everywhere. We helped by raising more than a million dollars and collected the necessary hydrologic data on river systems that Fish & Game didn't have the resources to collect. Mission accomplished at no cost to Fish & Game.

If it truly is the policy of this state not to sacrifice one resource for another then private instream flow reservations can help. For example, how do we know in any particular place whether fish and mining can co-exist? Fish need water. Mines need water. If mines take too much water - fish die. How do we know how much water fish need to live? We can file instream flow reservations, collect the five years of hydrologic data DNR requires and calculate how much water must be left in a river or lake to support fish. Now DNR and a mining permit applicant know how much water is available and can design a mine accordingly.

What if a mine needs water that has been reserved for fish – does the reservation stop the mine? No. The mining company can ask the DNR Commissioner to vacate or modify the reservation. If the greater public interest favors the mine, fish can be sacrificed. If the greater public interest favors fish, the company must make other plans. An uncomfortable choice – Yes. But that's why we pay the Commissioner so well.

All that a private instream flow reservation really does is provide the private applicant standing in the adjudication process to assure that the public interest in fish is represented, that the Commissioner is considering the best available data, and if a choice must be made between fish and another resource it is not done arbitrarily. What's not to like about that?

Please note the Eyak Preservation Council's mission is dedicated to the preservation of wild salmon habitat. it has come our attention that HR 77 would:

(1) eliminate the rights of Alaskan residents and organizations to apply for and secure instream reservations of water for salmon; (2) allow state officials to cut Alaskans out of important reviews ("Best Interest Findings") for large resource development; and (3) severely limit Alaskans' rights to challenge flawed decisions by government officials.

**The Eyak Preservation Council wants our email / letter (attached) included in the written testimony.**

**We are AGAINST HB 77.** These loosening of citizens rights regarding our waterways and wild salmon habitat is NOT acceptable and is unfair, and harmful to our rights for healthy environments and for our renewable economic resources. the people have a right to determine their clean water standards - not only government and corporations.

- Alaskans have a right to healthy salmon and an obligation to protect them. Don't strip away our rights to keep water in our streams for healthy fish. It's unfair.

-Put fish first! When allocation decisions are made in streams, wild salmon should get a priority over other out of stream uses.

-We demand balance and regional and citizen input and power in decision-making regarding in our fish management decisions. DNR routinely processes water use applications for mining, oil and gas corporations, but it almost never processes the instream flow applications needed to keep clean water for fish.

-Governor Parnell has repeatedly promised he would "never trade one resource for another." Tell him to keep his word, don't trade the water that our sustainable, wild fish need for short-sighted development projects.

-Alaska salmon streams are warming, and salmon are becoming more vulnerable to pollution, predation and disease; it's more important than ever to keep clean habitable water in streams and waterways to ensure healthy fish.
