A RESOLUTION

1 **Urging the United States Congress to pass legislation to open the coastal plain of the**
2 **Arctic National Wildlife Refuge to oil and gas exploration, development, and**
3 **production; urging the United States Department of the Interior to recognize the private**
4 **property rights of owners of land in and adjacent to the Arctic National Wildlife Refuge;**
5 **relating to oil and gas exploration, development, production, and royalties; and relating**
6 **to renewable and alternative energy technologies.**

7 **BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

8 **WHEREAS, in 16 U.S.C. 3142 (sec. 1002 of the Alaska National Interest Lands**
9 **Conservation Act), the United States Congress reserved the right to permit further oil and gas**
10 **exploration, development, and production within the coastal plain of the Arctic National**
11 **Wildlife Refuge; and**

12 **WHEREAS the oil industry, the state, and the United States Department of the**
13 **Interior consider the coastal plain to have the highest potential for discovery of very large oil**
14 **and gas accumulations on the continent of North America, estimated to be as much as**
15 **10,000,000,000 barrels of recoverable oil; and**

1 **WHEREAS** the "1002 study area" is part of the coastal plain located within the North
2 Slope Borough, and many of the residents of the North Slope Borough, who are
3 predominantly Inupiat, are supportive of development in the "1002 study area"; and

4 **WHEREAS** oil and gas exploration and development of the coastal plain of the refuge
5 and adjacent land could result in major discoveries that would reduce our nation's dependency
6 on oil produced by hostile foreign nations, help balance the nation's trade deficit, and
7 significantly increase the nation's security; and

8 **WHEREAS** the state's and the nation's future energy independence would be
9 enhanced with additional natural gas production from the North Slope of Alaska, including
10 what are expected to be significant gas reserves in the Arctic National Wildlife Refuge, and
11 the development of those reserves would enhance the economic viability of the proposed
12 Alaska Natural Gas Pipeline; and

13 **WHEREAS** domestic demand for energy continues to rise, and the United States
14 continues to depend on imports of oil from foreign sources; and

15 **WHEREAS** development of oil at Prudhoe Bay, Kuparuk, Endicott, Lisburne, and
16 Milne Point has resulted in thousands of jobs throughout the United States, and projected job
17 creation as a result of coastal plain oil development will have a positive effect in all 50 states;
18 and

19 **WHEREAS** North Slope production is declining; and

20 **WHEREAS** the Trans Alaska Pipeline System, a national asset that would cost
21 billions of dollars to replace, would have its useful physical life extended for a substantial
22 period if the additional reserves of recoverable oil from the coastal plain were produced; and

23 **WHEREAS** the Trans Alaska Pipeline System is currently being extended to leases at
24 Point Thomson, an area bordering the Arctic National Wildlife Refuge, and oil produced in
25 the Arctic National Wildlife Refuge would require only the additional construction of a
26 pipeline to Point Thomson to deliver oil to market; and

27 **WHEREAS**, while new oil field developments on the North Slope of Alaska may
28 temporarily slow the decline in production, only allowing access to the state's coastal plain
29 fields would enable the production volume of Alaska oil to increase to a significant degree;
30 and

31 **WHEREAS** opening the coastal plain of the Arctic National Wildlife Refuge now

1 allows sufficient time for planning environmental safeguards, development, and national
2 security review; and

3 **WHEREAS** the 1,500,000-acre coastal plain of the refuge makes up less than eight
4 percent of the 19,000,000-acre refuge, and development of the oil and gas reserves in the
5 refuge's coastal plain would affect a limited area as defined by the United States Congress;
6 and

7 **WHEREAS** 8,900,000 of the 19,000,000 acres of the refuge have already been set
8 aside as wilderness; and

9 **WHEREAS** the oil industry has shown at Prudhoe Bay, as well as at other locations
10 along the Arctic coastal plain, that it is capable of conducting oil and gas activity without
11 adversely affecting the environment or wildlife populations; and

12 **WHEREAS** the state will continue to strive to ensure the ongoing health and
13 productivity of the Porcupine and Central Arctic caribou herds and the protection of land,
14 water, and wildlife resources during the exploration and development of the coastal plain of
15 the Arctic National Wildlife Refuge; and

16 **WHEREAS** the oil and gas industry has developed directional drilling technology that
17 will allow horizontal drilling in a responsible manner by minimizing the development
18 footprint within the Arctic National Wildlife Refuge, and that directional drilling technology
19 may be capable of drilling from outside of the boundaries of the 1002 study area; and

20 **WHEREAS** the oil industry is using innovative technology and environmental
21 practices in new field developments, and those techniques are directly applicable to operating
22 on the coastal plain and would enhance environmental protection beyond traditionally high
23 standards; and

24 **WHEREAS** the state recognizes that the economic prosperity of the state is dependent
25 on available, reliable, and affordable energy; and

26 **WHEREAS** the state promotes the development of renewable and alternative energy
27 resources and created the Alaska Energy Authority to assist the state in advancing new energy
28 projects and technology; and

29 **WHEREAS** the Alaska State Legislature encourages the use of revenue from
30 development in the Arctic National Wildlife Refuge for the development of renewable and
31 alternative energy resources in the state;

1 **BE IT RESOLVED** that the Alaska State Legislature urges the United States
2 Congress to pass legislation to open the coastal plain of the Arctic National Wildlife Refuge
3 to oil and gas exploration, development, and production; and be it

4 **FURTHER RESOLVED** that the Alaska State Legislature urges that oil and gas
5 exploration, development, and production activity be conducted in a manner that protects the
6 environment and the naturally occurring population levels of the Porcupine caribou herd on
7 which the Inupiat, Gwich'in, and other local residents depend, that uses directional drilling
8 and other advances in technology to minimize the development footprint in the 1002 study
9 area, and that uses the state's work force to the maximum extent possible; and be it

10 **FURTHER RESOLVED** that the Alaska State Legislature urges the United States
11 Congress to pass legislation opening the 1002 study area for oil and gas development while
12 continuing to work on measures for increasing the development and use of renewable and
13 alternative energy technologies; and be it

14 **FURTHER RESOLVED** that the Alaska State Legislature urges the United States
15 Department of the Interior to recognize and respect the rights of Native landowners in and
16 adjacent to the Arctic National Wildlife Refuge 1002 study area, including the rights of the
17 Arctic Slope Regional Corporation and the Kaktovik Inupiat Corporation to develop their land
18 and resource entitlements received under the Alaska Native Claims Settlement Act and other
19 agreements; and be it

20 **FURTHER RESOLVED** that the Alaska State Legislature opposes any unilateral
21 reduction in royalty revenue from exploration and development of the coastal plain of the
22 Arctic National Wildlife Refuge and any attempt to coerce the state into accepting less than
23 the 90 percent of the oil, gas, and mineral royalties from the federal land in the state that was
24 promised to the state at statehood.

29 Honorable Nancy Pelosi, Minority Leader of the U.S. House of Representatives; the
30 Honorable Harry Reid, Majority Leader of the U.S. Senate; the Honorable Mitch McConnell,
31 Minority Leader of the U.S. Senate; the Honorable Ron Wyden, Chair of the Energy and

1 Natural Resources Committee of the U.S. Senate; the Honorable Lisa Murkowski and the
2 Honorable Mark Begich, U.S. Senators, and the Honorable Don Young, U.S. Representative,
3 members of the Alaska delegation in Congress; and all other members of the 113th United
4 States Congress.
