




FYI2 Age of Persons Served







Shelter Nights Provided by Victim Service




BATTERERS INTERVENTION PROGRAMS




During Fiscal Year 12, fifteen approved batterer intervention programs operated in Alaska. Eleven were community based Batterers Intervention Programs (BIP) and four were Prison Batterers Programs (PBP). All of these programs have the primary goal of victim safety. The Council collaborates with the Department of Corrections to provide these programs. In FY12, the majority of participants admitted into batterers' programs were court-ordered. Numbers in graphs are for services provided only by Council-funded programs.



PREVENTION-4TH R

- Emphasizes skill development through role plays and practice: negotiation skills, delay skills and yielding to peer pressure
- Promotes healthy relationships and draws the links among relationships and risk behaviors
- Provides whole-class, small group and dyadic discussion opportunities to process issues with peers and teacher, time to examine individual values, beliefs, boundaries and limits


COACHING BOYS INTO MEN



- *6 teams in Juneau, 1 in Ketchikan and 1 in Fairbanks implementing program this year
- *42 participants at January 2013 training
- *partnering with ASAA (Alaska School Activities Association)
- *Organizing technical support for coaches implementing the curriculum

The Thunder Mountain High School boy's basketball team sign a pledge against violence toward women and girls as part of the Coaching Boys into Men program they have joined. The pledge stated: "I pledge to never commit, condone or remain silent about violence against women and girls." The Juneau-Douglas Crimson Bears signed the pledge also, as did Governor Sean Parnell, who spoke to the fans in attendance. Coaching Boys into Men has been championed by the Falcons and Crimson Bears, with many opposing teams taking the pledge while in Juneau and local middle school sports teams becoming involved as well.
